### Call to Order

Council Vice President Ann-Frances Lambert called the meeting to order at 6:00 p.m. and presided.

## Citizen Comment

Gail Moskowitz, Jewish Community Federation Richmond member, Hadassah member, addressed Council and requested that Council not consider a proposed resolution requesting a ceasefire related to the conflict in Gaza.

Princess Blanding addressed Council and requested that Council listen to the Richmond Palestinian community's request for a ceasefire resolution related to the conflict in Gaza.

Amy Scharf, Jewish Community Federation of Richmond Board member, stated her appreciation for Council's work on behalf of Richmond residents. Ms. Scharf requested that Council refrain from taking action on the proposed ceasefire resolution related to the conflict in Gaza, and she also stated that the resolution would not stop the international conflict.

Mavis Green addressed Council and stated his appreciation for the city approving collective bargaining. Mr. Green requested that Council help expedite the process for approving a proposed labor deal and help support labor and trade city workers.

Maurice Black addressed Council and stated that the city still needed to approve a collective bargaining labor agreement with trade and labor city employees. Mr. Black also stated that trade and labor employees are responsible for essential work on behalf of residents, and he requested that the labor agreement be approved.

Laura Harris addressed Council and informed members that she recently worked in a dangerous enclosed space without properly trained employees. Ms. Harris stated that the collective bargaining labor agreement for labor and trade employees would help ensure that proper safety training is available for employees.

Derrick Golden addressed Council and stated his concerns about the amount of subcontractors used by the city. Mr. Golden also stated that an approved labor and trade agreement would help increase the hiring of permanent city workers.

### Public Hearing

Allan Chipman addressed RES. 2024-R007, and stated his concerns about the possible impact on residents wishing to address matters before Council.

Amy Oblinger, on behalf of a neighboring property owner, spoke in opposition of ORD. 2024-052, and stated her concerns about overcrowding with the allowance of two residences on the referenced lot of land.

Madeline McElgunn spoke in opposition of RES. 2024-R007, and stated that the proposed rule changes would create additional barriers between residents and Council. Madeline McElgunn also stated concerns about the difficulty contacting the city's Human Rights Commission.

Katherine Harville spoke in opposition of RES. 2024-R007, and stated that current issues with city transparency negatively impact the proposed changes. Ms. Harville also stated her concerns about the Citizen Comment Period only having eight available slots for speakers, and she stated that the number of speakers is not addressed in Council's Rules of Procedure.

Penny Page spoke in opposition of RES. 2024-R007, and stated that public comment has a long history in Virginia and requested that Council respect that tradition.

Victoria Vanzura, ORD. 2024-051 applicant, spoke in support of ORD. 2024-051, and stated that the request was not for a new driveway, but to complete the unfinished work of one. Ms. Vanzura also stated that she was trying to resolve the issue of an unfinished driveway in a legal way, and she noted the support of surrounding neighbors and civic associations.

Kurt Gottfried spoke in support of ORD. 2024-051, and stated that he did not see any negative impact with approving the special use permit. Mr. Gottfried also stated that other houses on the street have driveways, and that he believed the request was a special circumstance.

Will Gillette, representing ORD. 2024-052 applicant, spoke in support of ORD. 2024-052, and informed Council about the amount of public engagement that occurred regarding the proposed development at Rogers Street. Mr. Gillette also stated that he individually addressed setback concerns from surrounding neighbors.

Gabriel Mayer spoke in support of ORD. 2024-051, and stated his property also has a driveway on the same block. Mr. Mayer also stated that he believed the driveway will help increase parking availability on Noble Street.

*Councilor Katherine Jordan addressed the proposed rule changes referenced in RES. 2024-R007, and she inquired if individuals speaking virtually that experience technical difficulties would be prevented from speaking for 90 days.*

*City Attorney Laura Drewry stated that the intent of the rule change is not to penalize an individual experiencing technical issues with attending the meeting.*

*Councilor Stephanie Lynch addressed RES. 2024-R007, and stated that residents have additional ways to engage with Council through staff and Council standing committees.*

*Councilor Reva Trammell stated that she believed if residents had an easier way to identify and contact city departments, then the need to speak before Council would be less necessary.*

*Councilor Nicole Jones addressed RES. 2024-R007, and she recommended that Council amend the number of Citizen Comment speakers from eight individuals to ten.*

*Councilor Ellen Robertson addressed RES. 2024-R007, and stated that Council was working on the proposed changes for a large amount of time. Councilor Robertson also stated her concern that residents be assured that they would have access to Councilmembers.*

*Councilor Cynthia Newbille stated that the intent of RES. 2024-R007 is not to limit the voice of residents. Councilor Newbille also stated her willingness for further amendments after receiving feedback from residents.*

*Vice President Ann-Frances Lambert provided background information regarding ORD. 2024-051, and she invited city administration to address the proposed special use permit.*

Kevin Vonck, Director of Planning and Development Review, provided the procedural history of ORD. 2024-051, and he noted the reasoning of why the City Planning Commission recommended denial of the special use permit.
