That Article I, Section 1 of Ordinance No. 2023-071, adopted May 8, 2023, which adopted a General Fund Budget for the fiscal year commencing July 1, 2023, and ending June 30, 2024, and made appropriations pursuant thereto, be and is hereby amended by appropriating the remainder of the funds accepted pursuant to section 1 of this ordinance to the YWCA Richmond line item in the Non-Departmental agency in the amount of \$160,250.00 for the purpose of providing violence prevention and intervention services to newcomer, immigrant, and refugee youth.

PURPOSE: To authorize the Chief Administrative Officer to accept funds in the amount of \$249,000.00 from the Virginia Department of Criminal Justice Services, and to appropriate \$88,750 to a new special fund for the Office of the Deputy Chief Administrative Officer for Human Services called the "OIRE Youth and Family Violence Prevention Fund," and appropriate \$160,250 to the YWCA Richmond line in the Non-Departmental, all for the purpose of supporting our newcomer youth by providing trauma informed healthcare, teaching healthy relationship skills, reducing victimization, and building protective factors against youth violence.

BACKGROUND: The City of Richmond applied for and was awarded \$249,000.00 for the purpose of supporting our newcomer youth. These funds were secured for Richmond through a Virginia Department of Criminal Justice Services grant. The "Latine Youth and Family Violence Prevention Program" will work to assist newcomer immigrant and refugee youth with any previous trauma that may have been experienced during migration and to alleviate any future barriers and traumas that could be experienced while integrating into the City of Richmond. This will be achieved by providing trauma informed healthcare, teaching healthy relationship skills,

reducing victimization, and build protective factors against youth violence. The grant application was jointly developed with the YWCA of Richmond. Domestic, sexual, gender based, and family violence are significant components of the trauma that newcomer adolescents experience before, during and after they migrate to Richmond. This initiative will implement CDC- and NIH-identified strategies to prevent and mitigate youth violence, while leveraging both the City's of **Immigrant** and Refugee Engagement's strong relationships with communities and YWCA Richmond's deep expertise in domestic, intimate partner, sexual and gender-based violence prevention. The grant will fund a Bilingual Client Services Specialist and Bilingual Clinician to be placed with the YWCA and a Bilingual Outreach and Engagement Specialist placed with the Office of Immigrant and Refugee Engagement.
