Dear President Nye, Vice President Lambert and members of council,

We are writing to formally request that you put the new bond ordinance for the Diamond District project up for a referendum on the November ballot.

The public has had just over a month to vet the new bond structure; this is not a sufficient amount of time given the massive change. Most were not even aware of this special meeting that takes place today at 3PM when many workers begin their shifts or are already at work. We can't help but note that this process has been designed to limit public input as much as possible.

If this project fails, then all of the risk falls upon residents instead of upon the bond holders under the original CDA proposal. If you are so certain of the success of this project, you ought to be able to articulate the benefits to the public at the ballot box. Given your testimonies at various meetings, many of you have asserted that the public just doesn't understand the new deal. This is the same tired refrain from the Dominion Coliseum and Casino projects. Richmonders are smart and will hold you responsible.

As you know, Richmond for All's membership has played a large role in halting several high risk economic development deals in the city. Folks in our broader community have sent at least 171 letters to date to members of council, the mayor and the CAO. We believe you are underestimating the degree to which Richmonders are tired of handouts to the ultra rich.

The best strategy for economic development in the city is not to hand public dollars to out-of-state private interests and hope that they toss us a crumb. The best strategy to guarantee economic development is to ensure that every student receives free, high quality public education, that everyone has access to healthy food, that everyone has a home, and that we have high quality public service.
