

Detailed Description of Proposed Work:

We have received permission from our property owner, Highwoods Properties Inc., to place signage on the rounded corner on the front of our building to honor our former CEO and current Chairman, John Adams. Our Director of Operations, Carmina Drummond, will be acting as an authorized agent on behalf of Highwoods Properties.

The sign will be approximately 4'x4' and will be created by FastSigns out of silver cast brushed aluminum lettering in a standard font (the artwork and a mockup of the sign on the building is attached). The sign will not be illuminated and will be installed by FastSigns via bucket truck, which we can easily park on our breezeway while still allowing access for cars and trucks to pass through.
