Detailed Description of Proposed Work

Install a new storage shed at the rear of the lot for 2912 E. Leigh St.

- 120 square feet, 10 x 12, 6' 4" wall height
- A-frame
- Wood siding, lap, 50 year, smooth, painted to match house
- Shingled roof
- 1 vinyl window, 18" by 28", no shutters
- Ridge vent
- Double doors 72" tall 5' wide with locking T-handle, on long side facing west toward gravel parking

Other building details

- 6" Board eave overhang
- 5/8" plywood floor
- 4x4 treated runners
- Treated 4outermost floor joists
- Spring loaded barrel bolts for security
- 6 piano hinges to prevent sagging
- Floor joists and walls 16"on center
- Double plated side walls
- Metal Trim
- 2x4 constructed

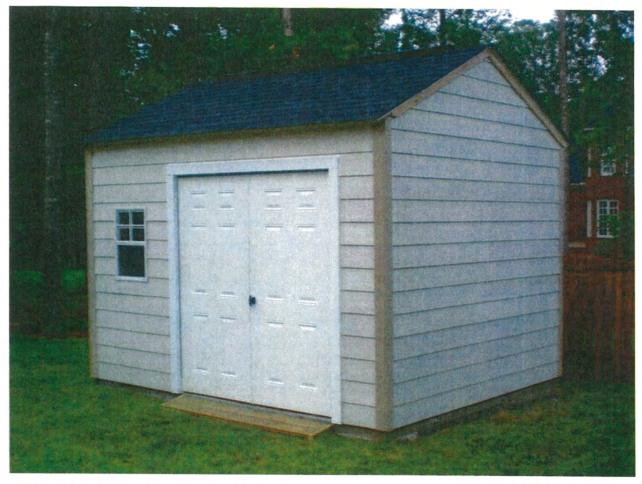

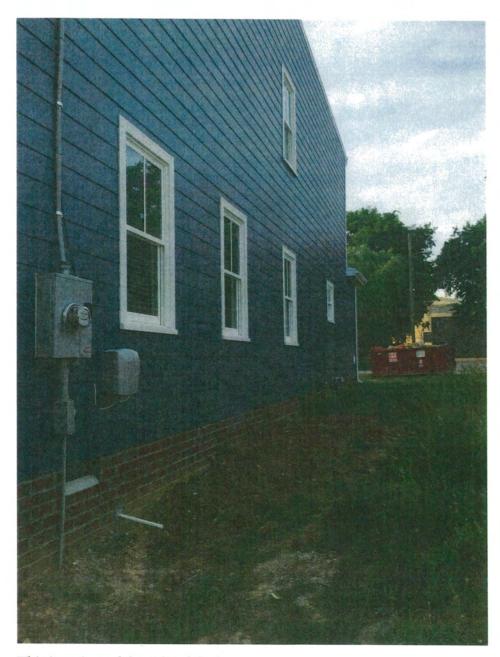
The shed would look like this one, built by the same contractor. The color would be different and would match the house.
