Jeff,

I am on vacation this week, so I am not able to testify at the upcoming UDC meeting on the BRT project. However, I do want to submit some comments for the UDC members to consider:

- The Bike Walk RVA staff at Sports Backers have been engaging in an ongoing conversation with GRTC and City of Richmond staff to ensure that the design of Broad Street as part of the Pulse GRTC project is as safe and comfortable as possible for people who need to walk and bike along and across Broad Street.
- The current design, which features a 4-foot median (increase from 2 feet) and six dedicated pedestrian crossings at otherwise unsignalized intersections, is a tremendous improvement from earlier versions of the project design.
- We would still like assurance that HAWK signals or some other high-intensity pedestrian crossing signal at the six pedestrian crossings will be installed to help people cross the street safely. Currently, installation of those signals seem to be contingent on if there is money available in the project budget and if it meets VDOT "warrants".
- Overall, we have been pleased with the increased transparency and willingness to collaborate on the design of Broad Street on the part of the City of Richmond and GRTC, and our previous concerns over pedestrian safety have been addressed.
- The incorporation of bike parking in the station area plans and bike racks mounted on the front of the buses will make the Pulse BRT a compliment to the bicycle network that is being built out in the Bicycle Master Plan and will help people get around Richmond in a more multi-modal manner.

Dear Mr. Eastman,

I hope you will provide this e-mail to the Urban Design Committee and to the Planning Commission before their meetings regarding GRTC's proposed BRT project.

One aspect of the development of the proposed BRT project disturbs me. In the conceptual plans presented to the Urban Design Committee, there is now a 1.4 mile gap between stations, roughly centered at Malvern Avenue. Considering the importance of established and future development within this segment of the BRT route, this seems to be a serious design flaw that the UDC and the Planning Commission should not overlook. This gap is centered on my neighborhood. I regularly ride GRTC buses, and I am very disappointed.

In GRTC's early project development documents, the station location criteria led to establishing a station at Hamilton Street. This station was removed with no notification to neighborhoods west of Hamilton. In the "Application for UDC Review," you can see that the Hamilton Street station was moved to Cleveland Street. The "Final Station Location Report V3," states that this decision was not based on a field review or any professional analysis of the criteria for station locations. This decision was dictated by the City of Richmond, was not documented, and was not analyzed by GRTC's consultant team.

I have been unable to find anyone willing to take responsibility for deciding to remove service for my neighborhood on the proposed BRT project. I have not seen any documentation of this decision. It seems to have been an arbitrary decision. I hope you will require GRTC to revisit the decision to eliminate the Hamilton Street station considering their original station location criteria. I believe that a rational analysis and design would lead to reestablishing this station.

Please let me add some history on this issue. In May 2014, I attended a public meeting concerning the Bus Rapid Transit project proposed by GRTC. I learned that the proposed route would serve my area with a station at Hamilton Street, approximately halfway between stations at Staples Mill Road and Robinson Street. I read the GRTC Station Area Screening Study report, which emphasized criteria such as distance between stations, community facilities, and current ridership on GRTC routes. Although there would be a limited number of BRT stations, they would be spaced no more than one mile apart. As a regular bus rider, I was elated to see that GRTC's BRT system would serve my neighborhood and the longtime residents and employers in the Malvern Avenue area.

Imagine my surprise and anger when I attended the public meeting on January 27. I learned that GRTC eliminated the proposed station at Hamilton Street that served my area and added a station at Cleveland Street. I am appalled that anyone would suggest removing service from someone else's area to improve service in his own area. <u>I do not oppose the addition of service in any area, but eliminating the Hamilton Street station leaves a 1.4 mile gap between stations, centered at Malvern Avenue.</u>

Riders who would board/depart for the following places will be underserved by the lack of a station between Hamilton and Westmoreland:

- Thomas Jefferson High School
- Guardian Place (senior citizen community)
- Estes Express Lines (corporate HQ)
- United Methodist Family Services (UMFS)
- International Mission Board (Southern Baptist Convention on Monument Avenue)
- Richmond Technical Center (on Westwood Avenue)
- Multiple small businesses on Broad Street, Westwood Avenue and Dabney Road
- Multiple apartment and condominium complexes along Hamilton Street
- Westbound Broad Street connection to GRTC's Route 91 (Laburnum Connector)

Longtime residents in the following neighborhoods will be underserved by the lack of a station between Hamilton and Westmoreland:

- Sauer's Garden
- Jefferson Terrace
- Malvern Gardens
- Westhampton (eastern portion)

Last year, the Planning Commission approved the development of a former office building in my neighborhood into an apartment building. Soon, UMFS will be developing the open space on their property. The former offices of the Virginia Department of Game and Inland Fisheries are likely to be redeveloped soon. New businesses are moving into vacant spaces along this part of Broad. And no one wants to see Estes leave the city. A BRT station would be a catalyst to maintaining the momentum of further development.

It seems obvious to me that a BRT station is needed somewhere between Hamilton and Westmoreland. I hope that the members of the UDC and the Planning Commission will agree. Thank you for providing them with my input.
