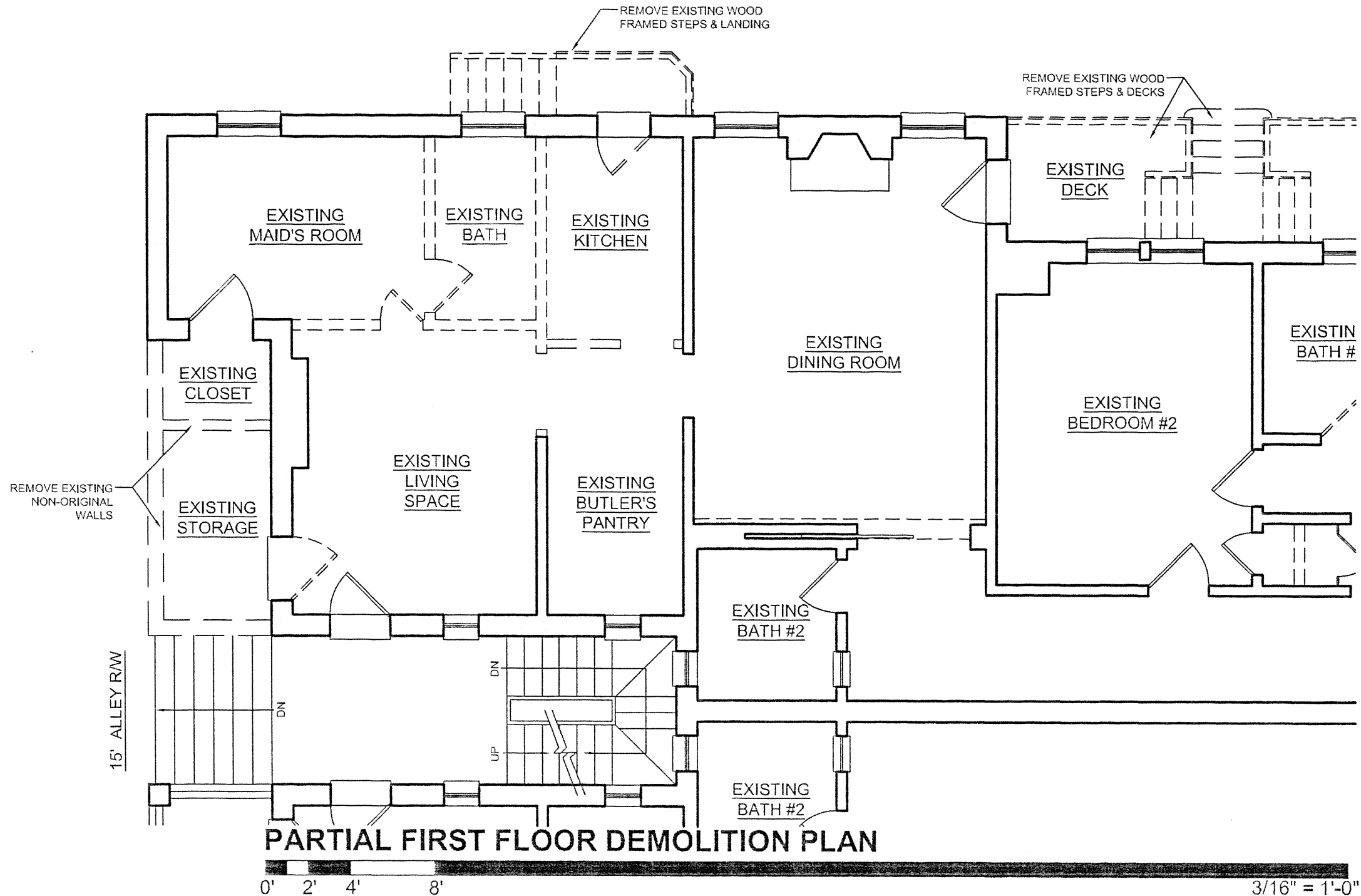

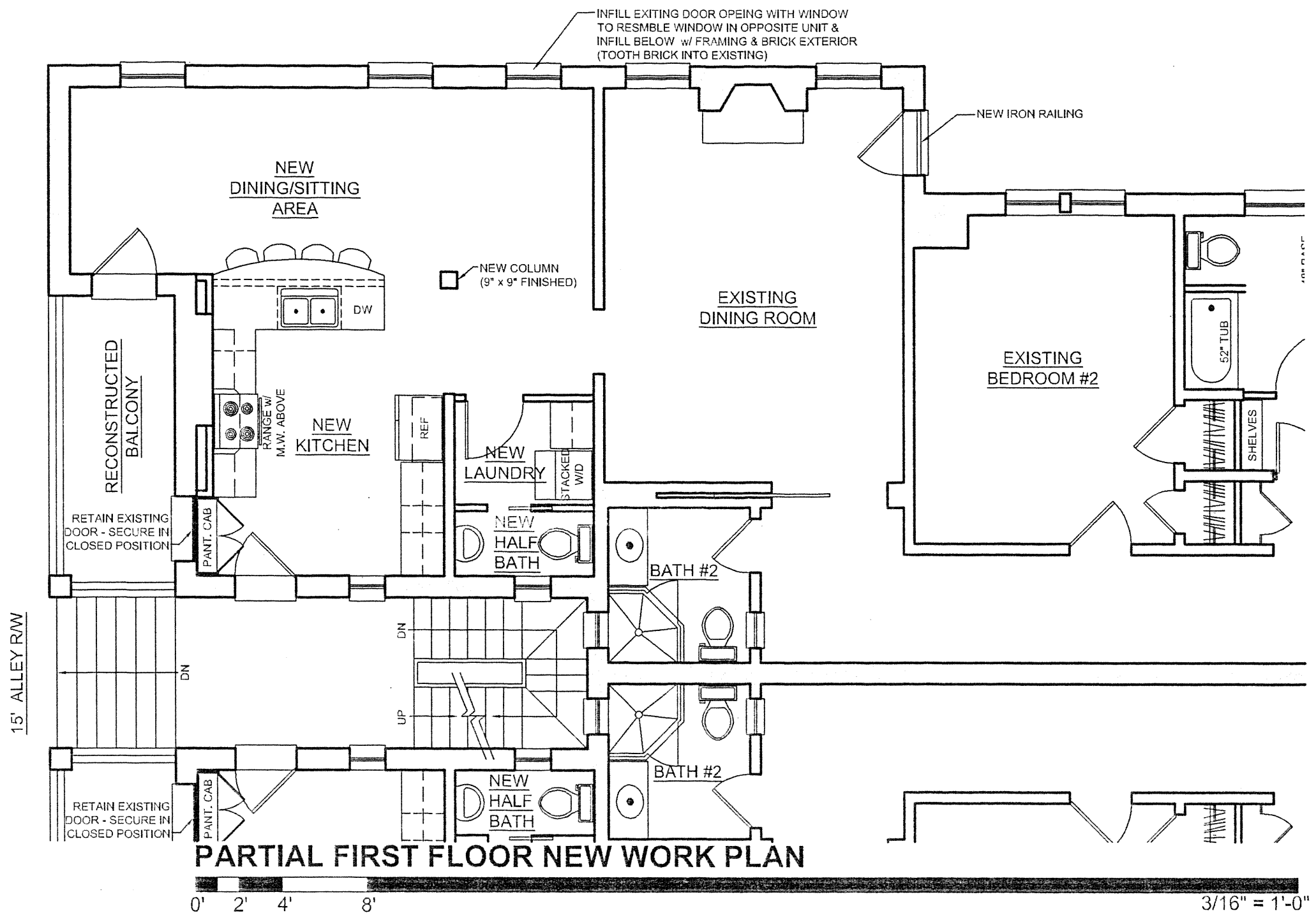

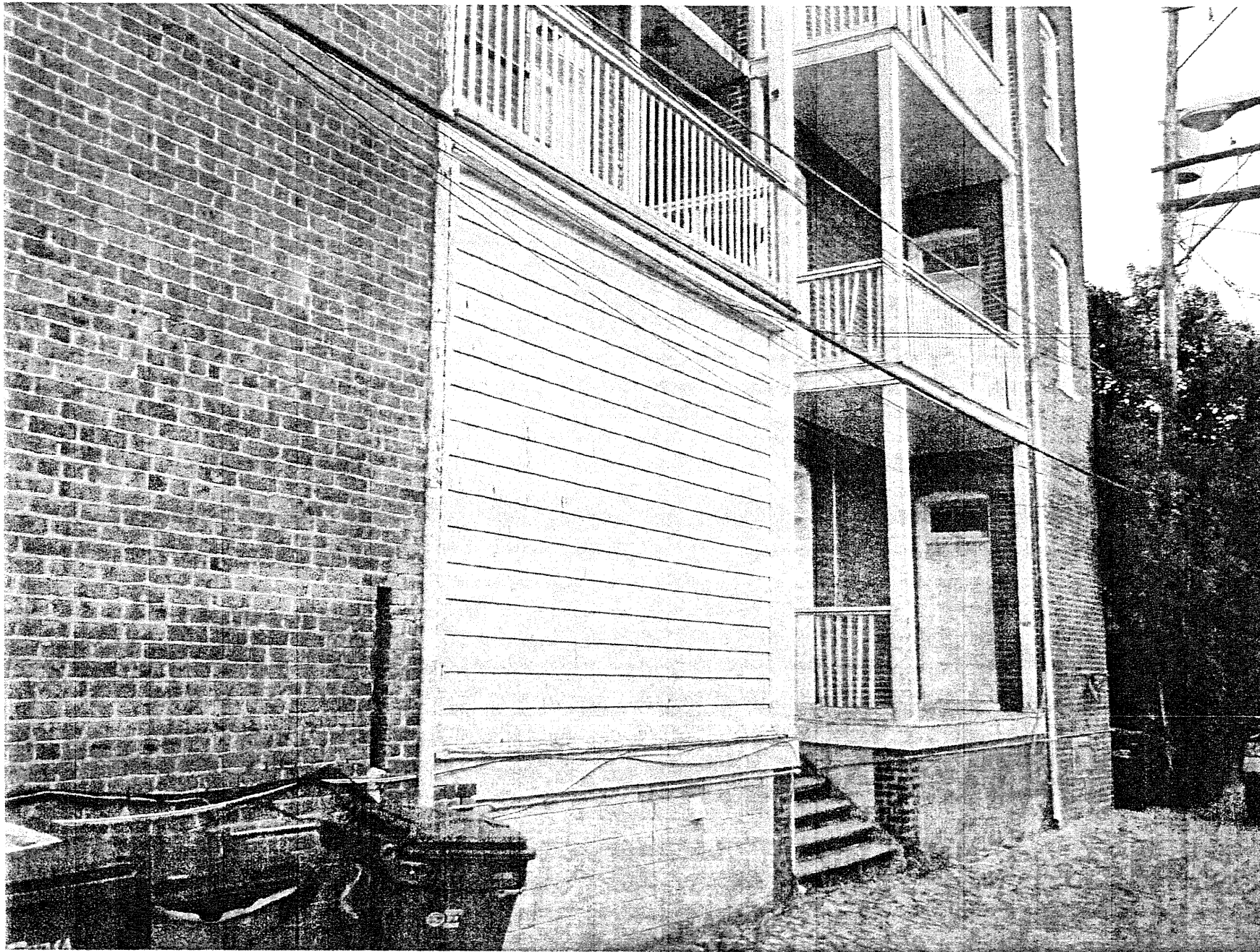


PHOTO OF EXISTING ENCLOSURE & TYPICAL BALCONY BEYOND
