- (b) A written report, submitted monthly by the end of the month beginning with December, 2015, identifying all existing contracts procured under section 74-72 of the Code of the City of Richmond (2004), as amended, and as may be recodified in the future, that, since the last such report, have been:
  - (1) Modified via change order or contract modification, stating for each the dollar amount of the change and the change in scope or other reason for the change in dollar amount;
  - (2) Renewed or extended, stating for each the period of time for which the contract has been renewed or extended and the new expiration date; and
  - (3) Re-solicited, stating for each sufficient information to enable a person reading the report to view a copy of the new solicitation on the internet."

At the beginning of the line, insert the section number "§ 3."

After the inserted word "doors", insert the text "and wheel size of at least 14 inches"

After the inserted word "article", strike the word "or" and insert a comma

#### Page 4, Line 7

After the comma following the word "equipment", insert the text "or to be unsafe" followed by a comma

## Page 9, Line 15

After the stricken word "and", insert the text "shall last for 12 months following its issuance and"

## Page 10, Line 21

At the beginning of the line, strike the inserted text "Notwithstanding subsection (5) above, the driver is convicted of, pleads guilty to, or pleads nolo contendere within a three year period to two or more violations of making" and insert the text "The chief finds, after investigation, that the driver, within a three-year period, has on two or more occasions made"

#### Page 11, Line 12

After the section number "\sqrt{2.", strike the text "That section 110-56 of the Code of the City of Richmond (2004) be and is hereby **repealed** as follows:"

#### Page 11, Line 14

At the beginning of the line, strike the stricken text "[Sec. 110-56. Certificate holder to have telephone listing. Every owner holding a certificate of public convenience and necessity issued pursuant to this article shall provide and maintain at all times in the Greater Richmond telephone directory a listed telephone in the name in which the certificate holder is doing taxicab business, by which calls may be made for taxicab service. If the certificate holder operates five or more taxicabs, the telephone listing shall also appear in the Greater Richmond classified telephone directory.
