CHAMBER EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

President Michelle Mosby called the meeting to order and presided. Upon the President's request, Faye Smith, Senior Assistant City Clerk, provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines and conduct during the meeting.

APPOINTMENTS/REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

President Michelle Mosby, on behalf of Richmond City Council, and Selena Cuffee-Glenn, Chief Administrative Officer, on behalf of Mayor Dwight C. Jones, proclaimed the month of January 2016 as Richmond Stalking Awareness Month. Representatives of the YWCA of Richmond accepted and thanked city officials for the recognition.

Councilor Kathy Graziano, on behalf of Richmond City Council, presented Mr. Robert Kelly, Chair of the Richmond Christmas Parade Organizing Committee, with the Richmond Community Service Award honoring him for his work organizing the city's annual Christmas parade. Mr. Kelly accepted the recognition and thanked community partners, volunteers and sponsors for their resources and hard work in making the parade the biggest event in Richmond.

CITIZEN COMMENT

Wanda Jones-Wilkerson addressed Council stating that she is opposed to the reappointment of the current tenant representative to the Richmond Redevelopment and Housing Authority (RRHA) Board of Commissioners, and residents need a commissioner who is more responsive to their concerns.

Linda Jordan, President, Coalition Against Violence, addressed Council stating that the coalition has provided assistance to families impacted by homicide in Richmond for over 25 years and expressed a desire for the city to bring awareness to the work of the organization.

Peggy Jones addressed Council expressing support for Richmond Public Schools' (RPS) proposed budget and the school system's teachers.

Charlene Harris addressed Council expressing opposition to the reappointment of the present tenant representative to the RRHA Board of Commissioners, stating that it is time for new resident leadership on the board.

L. Shirley Harvey addressed Council alleging embezzlement of taxpayer dollars in the city and urged Council to launch a probe into the matter.

Colleen Marino addressed Council expressing concern over the city's investment in its schools and support for the full funding of RPS.

To amend City Code § [46.1-69] 13-221, concerning inspection reports for fire prevention systems, for the purpose of requiring persons or firms testing or inspecting fire prevention systems to be certified and qualified to provide such testing or inspecting services. (As Amended)

This ordinance was adopted.

ORD. 2015-190

To amend City Code § [46.1-3] 13-22, concerning the authority of the fire code official at fires and other emergencies, for the purpose of authorizing the fire code official to regulate open burning, and to amend ch. 13, art. V, div. 3 of the City Code by adding therein a new section 13-199 for the purpose of prohibiting open burning without authorization from the fire code official and failing to contain or extinguish any open burning when requested by the fire code official. (As Amended)

To amend City Code §§ [38-154] 11-105, concerning weeds and other vegetation, [38-155] 11-107, concerning violations and notice, and [38-156] 11-108, concerning abatement by the City, and to amend Appendix A of the City Code by adding therein a new fee for City Code § [38-156(b)] 11-108(b) for the purpose of imposing one notice per growing season, designating the amount of administrative charges for abatement by the City, imposing civil penalties for violation or such sections, and requiring the Director of Planning and Development Review to prepare and deliver to the City Council and the Chief Administrative Officer a report concerning the costs incurred, charged to property owners and paid to the City associated with the City's efforts to abate violations of such sections. (As Amended)

ORD. 2015-205

To amend ch. [46.1] 13, art. V, div. 3 of the City Code[,] by adding therein a new section [46.1-64] 13-201, concerning maximum standpipe outlet pressure, for the purpose of regulating the maximum outlet pressure for firefighting standpipe systems. (As Amended)

This ordinance was adopted.

ORD. 2015-207

To amend ch. [46.1] 13, art. V, div. 3 of the City Code[,] by adding therein a new section [46.1-62] 13-202, concerning fire escape examination and maintenance, for the purpose of requiring the examination and maintenance of all fire escapes on buildings within the city. (As Amended)

This ordinance was adopted.

ORD. 2015-252

To authorize the Chief Administrative Officer to accept funds in the amount of \$381,749.00 from the State Compensation Board and to appropriate the increase to the Fiscal Year 2015-2016 General Fund Budget by increasing estimated revenues and the amount appropriated to the City Treasurer by \$2,622.00, the Department of Finance by

\$15,344.00, the Judiciary by \$57,713.00, and the City Sheriff by

\$306,070.00 for the purpose of funding a two percent salary increase for the City's constitutional officers and their employees.

Opposition

Earl Bradley spoke in opposition of the proposed legislation stating that a forensic audit report is necessary to ensure that the city's finances are accurately and lawfully transacted.

This ordinance was adopted.

ORD. 2015-253

To amend City Code § 8-7, concerning the naming of City facilities, for the purpose of excluding from the provisions of City Code §§ 8-7-8-10 any City-owned building leased by the City to a tenant when the lease grants the tenant the right to transfer naming rights to that building.

Councilor Parker Agelasto stated that such proposed ordinances need a clawback provision should citizens petition against the name of a city-owned building in years following enactment.

To authorize the Chief Administrative Officer, on behalf of the City of Richmond, to execute a First Amendment to Lease and Franchise Agreement between the City of Richmond, Virginia, and Richmond Performing Arts Center, L.L.P., for the purpose of providing for the transfer of naming rights to the downtown performing arts complex that includes the Carpenter Theatre by Richmond Performing Arts Center, L.L.P.

Opposition

Whitney Whiting spoke in opposition of the proposed legislation urging Council not to approve legislation giving Dominion Virginia Power naming rights to Richmond CenterStage.

Michael James-Deramo spoke in opposition of the proposed legislation alleging that Dominion engages in unethical business practices.

Drew Gallagher spoke in opposition of the proposed ordinance alleging that Dominion's pipeline proposal will mean the destruction of many of Virginia's historical landmarks; therefore, it does not deserve naming rights to CenterStage.

Sarah Dawson spoke in opposition of the proposed ordinance stating that Dominion is an active member of an organization whose goal is to dismantle federal climate change regulation and is the largest carbon polluter in the state.

Logan Miller spoke in opposition of the proposed legislation asking Council not to approve the name change request for a corporation that will allegedly use eminent domain to pollute and destroy private property.

Miranda Rosenblum spoke in opposition of the proposed legislation stating that she does not want one of Richmond's public art centers named after a company that allegedly pays for undue political influence.

Jordan Summerville spoke in opposition of the proposed ordinance alleging that Dominion uses its political influence to push increased costs on to consumers and should not have naming rights to CenterStage.

Sam Wellborn spoke in opposition of the proposed ordinance stating that he is disappointed that Dominion has failed to take the risks of climate change seriously and asked that Council not support the proposed legislation.

Scott Burger spoke in opposition of the proposed legislation stating that Dominion has donated millions to CenterStage that will be of minimal benefit to the public.

Christine Yazbeck spoke in opposition of the proposed legislation asking Council to thoroughly review the business practices of Dominion before voting on the proposed ordinance.

Support

Bob Mooney, CenterStage Foundation Board of Directors member, spoke in support of the proposed legislation stating that Dominion is a great philanthropic company, and the board would be a proud to have Richmond CenterStage renamed to Dominion Arts Center.

Councilor Parker Agelasto stated that he supports the proposed legislation as it pertains to a financial transaction that will give naming rights to Dominion for 15 years.

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute a Performance Agreement, as amended, between the City of Richmond, the Economic Development Authority of the City of Richmond and Fulton Hill Properties, LLC, for the purpose of providing an economic development grant to facilitate the development of at least ten affordable housing units and ten workforce housing units in the area generally bounded by Carlisle Avenue, Goddin Street, and Union Street. (As Amended)

This ordinance was adopted.

ORD. 2015-256

To close, to public use and travel, a portion of Northampton Street, located between Carlisle Avenue and Goddin Street and consisting of 9,978± square feet, upon certain terms and conditions.

This ordinance was adopted.

ORD. 2015-257

To authorize the special use of the properties known as 910 Goddin Street, 1000 Goddin Street, 4907 Goddin Court, a portion of 1000 A Carlisle Avenue, 1000 B Carlisle Avenue, 1021 Carlisle Avenue, and a portion of Northampton Street for the purpose of authorizing multifamily dwellings with up to 204 dwelling units and accessory parking, upon certain terms and conditions.

This ordinance was adopted.

ORD. 2015-258

To amend Ord. No. 2000-218-231, adopted May 22, 2000, which authorized the property known as 1000 Carlisle Avenue for the purpose of the conversion and occupancy of the existing building as an arts center and performance and reception facility, together with accessory off-street parking, substantially in accordance with the attached site plan and floor plans, to authorize up to 62 multi-family dwelling units and commercial uses and to remove part of 1021 Carlisle Avenue, part of Rear 901 State Street, and 910 Goddin Street, and reduce the required accessory off-street parking, upon certain terms and conditions.

This ordinance was adopted.

ORD. 2015-259

To declare surplus and to direct the sale of City-owned real estate located at 910 Goddin Street and 1000 Goddin Street for \$80,000.00 to Fulton Hill Properties, LLC, for the purpose of enabling the redevelopment of the property.

Support

Cheryl Groce-Wright spoke in support of proposed Ords. 2015-255, 2015-256, 2015-257, 2015-258, 2015-259 and 2015-264, stating that the proposed development will increase density in the community of Greater Fulton thereby spurring more economic growth.

Earl Bradley spoke in support of proposed Ords. 2015-255, 2015-256, 2015-257, 2015-258, 2015-259 and 2015-264 stating that there will be more job opportunities; however, the flawed economic development processes in the city need reform.

Councilor Parker Agelasto stated that, though he supports proposed Ords. 2015-255, 2015-256, 2015-257, 2015-258, 2015-259 and 2015-264, because the project should result in a sizeable return on investment to the city, he is concerned with the lack of information provided to Council about the project.

Councilor Cynthia Newbille stated that proposed Ord. Nos. 2015-255, 2015-256, 2015-257, 2015-258, 2015-259 and 2015-264, will mean the revitalization of a community that has gone neglected for decades and urged her Council colleagues to vote in support of the legislation.

Councilor Jonathan Baliles stated that the impact of proposed Ords. 2015-255, 2015-256, 2015-257, 2015-258, 2015-259 and 2015-264, will be positive for the Fulton area but city administration needs to be more forthcoming and thorough in its approach to economic development deals.

This ordinance was adopted.

ORD. 2015-260

To authorize the special use of the property known as 2112 Monteiro Street for the purpose of authorizing a multifamily dwelling with up to 18 dwelling units, upon certain terms and conditions.

Opposition

Nicole Neilson spoke in opposition of the proposed legislation stating that traffic, trash and noise will increase in the area and less parking will be available should Council approve the special use request.

Support

Rhonda Gilmer spoke in support of the proposed legislation stating that, while she supports the overall proposed project, she is concerned about increased noise, limited parking and the dwelling's potential impact on property values.

Clark Glave spoke in support of the proposed legislation stating that he is one of the owners and developers of the property at 2112 Monteiro Street and addressed the concerns of surrounding residents.

This ordinance was adopted.

ORD. 2015-261

To authorize the special use of the property known as 3100 East Marshall Street for the purpose of waiving the parking requirement for a two-family dwelling and a dwelling unit located in an accessory building, upon certain terms and conditions.

This ordinance was adopted.

ORD. 2015-262

To authorize the special use of the property known as 3111 West Clay Street for the purpose of permitting a social service delivery use, upon certain terms and conditions.

This ordinance was adopted.

ORD. 2015-264

To authorize the Chief Administrative Officer, on behalf of the City of Richmond, to execute a Utilities Agreement between the City of Richmond and Fulton Hill Properties, LLC, for the purpose of facilitating the relocation of an existing City sewer utility easement.

To amend City Code § 13-190, concerning the removal and closure of underground storage tanks, for the purpose of removing the exception that a tank may be abandoned if empty and to require soil testing to determine the contents of the tank, and to amend the fees set forth in Appendix A of the City Code for City Code § 13-160, for the purpose of removing the fee for the exception that a tank may be abandoned if empty and increasing the fee for filling or removing residential heating oil tanks of less than 1,100 gallon size.

This ordinance was adopted.

ORD. 2015-270

To amend ch. 13, art. V, div. 3 of the City Code, concerning amendments to the fire prevention code, by adding therein a new section 13-200, for the purpose making it unlawful for any person to use or operate a temporary heat source to heat the interior of a building, structure or premise to a temperature above 100 degrees Fahrenheit for pest control treatment purposes unless such person has complied with certain conditions, and to amend and reordain the fees set forth in Appendix A of the City Code for City Code § 13-160 by adding therein a new fee for the permit described in City Code § 13-200, for the purpose of imposing a separate fee for thermal pest control treatment permits.

This ordinance was adopted.

ORD. 2015-271

To amend and reordain City Code § 9-58, which assigns polling places in the city, to relocate and establish a new polling place for Precinct 911.
