<u>PURPOSE</u>: To authorize the Department of Justice Services to accept additional grant funds in the amount of \$13,081 from the Virginia Department of Criminal Justice Services for the purpose of providing a 2% salary increase for full-time employees of Local Pretrial Service Act and Comprehensive Community Corrections Act.

<u>REASON</u>: To recruit and retain knowledgeable employees with relevant experience and skills to administer correctional evidence-based practices. The increase will assist the Department of Justice Services in meeting the cost of living increase and keep salaries competitive with equivalent positions.

RECOMMENDATION:

The City's Administration recommends adoption of this ordinance.

BACKGROUND: Due to an increase in state revenue, the Virginia General Assembly, during the 2015 session, approved a number of increases in state budgets for FY16. The Governor also approved the proposed increases. As specified in the Appropriations Act under the Central Appropriations section, Item #467 – Compensation and Benefit Adjustments R.1.d., salary changes for local employees supported by the Commonwealth were included in the increases. The increases were added to Local Probation and Pretrial

FISCAL IMPACT: The Department of Justice Services is not required to provide a match. There is no impact anticipated.
