
PRELIMINARY PLAT OF CHURCH HILL NORTH SUBDIVISION





- 15. Property within the limits of this subdivision is located in Zone X, areas determined to be outside the 0.2% annual chance floodplain, as shown on the FEMA Flood Insurance Rate Map Number 5101290042D for the City of Richmond, dated April 2, 2009.
- 16. Property within the limits of this subdivision contains wetlands. On behalf of The Community Builders, Inc., Timmons Group environmental scientists Ben Snyder and Ethan Virts conducted a field delineation on September 21, 2014 and January 20, 2016 to identify jurisdictional Waters of the U.S. (WUS) and wetlands within the project study limits. The location is shown on the plans. The designated wetlands do not extend beyond the tops of banks of the creek.
- 17. Property within the limits of this subdivision is located in Chesapeake Bay Preservation Areas designated by the City of Richmond, Virginia pursuant to Chapter 50 of the City Code of 2004. A perennial stream determination was performed in June of 2008 by Timmons Group. The wetland delineation was used in conjunction with the stream determination to determine the limits of the Resource Protection Area which is denoted on the plans.
