Re: Horticulture and Maintenance buildings proposed for Hampton Street location

The proposed location of this horticulture/maintenance building and parking structure will mar a beautiful historic landscape, lie heavy upon the land, and encroach upon a neighborhood. The proposed City-owned building that the Urban Design Committee is scheduled to hear on Thursday morning, May 7, at 10:00AM should be hidden as utility buildings usually are. No one can dispute the great service the Maymont Foundation provides the neighborhood and region now. Unfortunately, the unsustainable nature of this poorly located building would be a sad legacy for years to come.

These are the three issues that I believe the Urban Design Committee should consider:

Beautiful Landscape: The proposed location off of Hampton Street is at the southern end of a historic grove of trees in Byrd Park on a hill overlooking the Maymont estate. Shield's Grove was referred to as an "ancient forest" in a newspaper article from 1926 and appears named on maps from the 1800's. Early park designers were especially excited about this natural area for city folk to experience. Shield's Shelter was placed here in the 1930's to provide a special picnic area.

Large Building/Pavement Footprint: Current designers of this proposed City building have worked mightily to provide landscaping that would diminish its industrial appearance. But in the end, they still have drawn a large building and much pavement which are located on a slope, within 200' of a stream, accessed by a hidden driveway on a hilly curved road.

Neighborhood and Visitors: Neighbors will have to contend with a new building and all the noise, fumes, trucks entering and exiting the roadway, lighting, and unforeseen impacts where now there is a pretty hill. Visitors coming by foot and wheelchair on a sidewalk built specifically for handicapped access to the current Hampton entrance will be first greeted by a driveway and utility building. Cyclists may have to slow on a hill they can currently speed down.

The area around Shield's Shelter is a little shabby now, but with Maymont's and Byrd Park's volunteers working together it could be restored to provide a natural experience once again. Operations on the estate are not for the City to decide, but as a citizen I would want to see a system that works well for the future when severe weather events are predicted to be more and more frequent. A large building on a slope with operations that would enshrine a heavy carbon emissions footprint is not sustainable. A driveway (20 feet shy of a cut-through from Hampton to Shield's Lake Road) is not in the spirit of a more bike, walking and handicap accessible future.

Dear Chairperson Almond and UDC Members,

I am a resident of Byrd Park and have lived in the neighborhood since 2001. I grew up in suburban Richmond and love both the City and the surrounding parks. However, I have concerns with the new maintenance facility that is being reviewed for construction. I am NOT opposed to a new facility, as I am sure one is needed, but I do have three major concerns that I feel should be addressed prior to an final approval.

The first concern is the loss of trees. This property is part of the old Shields Grove with trees that date back over 100 hundred years. If this building is to the be approved, I ask that as many trees be saved and that any parking facilities be gravel or pavers as we do NOT need additional storm water runoff in and around the two parks. Trees do not need to be removed so that we can put in a new parking lot.

The second concern is traffic. This plan includes new access and enhanced parking along Hampton Street which will no doubt cause additional traffic and wear on the park's roads. Additional maintenance vehicles will be using these roads. The park roads that are NOT maintained by Public Works as they are considered private roads. They receive no state funds and thus funding and improvements to them are limited. Byrd Park should not be seen as a cut through or a parking lot for any group or organization. If the facility is built at access from Hampton Street should be limited and Maymont vehicles should traverse directly into Maymont and not onto Hampton Street.

Finally the last, and most important, issue is the location. Maymont, by its agreement, is to control and maintain the one hundred acre estate from the Dooley family. However over the last 50 years this "line" between Byrd Park and Maymont Park has continued to move north. The old bathhouse facilities for Shield Lake (when it was the swimming pool) no lye partially inside the fence of Maymont. A fence built in 1960s and not located along any recognized line. The comfort station bathrooms built to serve the adjacent shelter were demolished in the early 2000s and the parking lot for the current Nature Center at Maymont have been incorporated into Maymont Park. Maps presented in recent year have shown Maymont going all the way to Amelia Street. Myself and many neighbors are concerned about this "unmarked" boundary line. I recommend that until a formal boundary line is surveyed distinguishing the two parcels that no project should be approved.

As a last point, I wanted to add that I am very frustrated that notification of this meeting was never sent to our civic league. I have am currently an officer in the league and we only received notice via our Councilmember. One cannot reach Randolph without touching the parts of the Byrd Park Civic League or Maymont neighborhoods. Our league reaches all the way to Amelia Street and we have active members in this area. Our boundary maps and contact information are correct on the City's own web site and we receive notices from other City agencies via US mail and email but we never formally notified of this hearing.

I am writing today in opposition to: UDC Ref# 2015-13, the plan to build a garage across from 1401 Hampton Street. I oppose this construction and any construction at this site; for the sake of brevity, three reasons.

This is one of the most open and unspoiled views in the park system from Shields Woods to the Maymont Mansion. This is the original view, in that this is what James and Sally Dooley saw the morning they rode horseback from their home on Franklin Street to the dairy farm that became Maymont. This is the historic side of the park. To build this type of structure right at the historic gate diminishes this unspoiled beauty. Boards and directors may come and go, but these inspiring views belong to us forever. We are charged by the Dooley's still, with keeping it unspoiled.

The second issue I have with this construction is the process or lack of process over a thing that permanently alters our park and directly that impacts my neighborhood. It is my understanding from speaking with foundation board members past and present that most of these decisions are made by very few "Officers" on the Maymont board and are made with the guidance of the director of the foundation and park. Then presentations are made to the broader board later, and at the end, once the die is cast, sometimes to the neighbors. In my opinion, over the years the terms "the foundation", "the board", are increasingly terms of art. Major plans, goals, and agendas come and go depending on a giving cycle and who gives what and when, directs the "planning". For example, in 2008, it was deemed necessary to build what was projected to be a 24 million dollar "Maymont Center" in the middle of the park. The next year, that vision changed and that plan was abandoned. The perpetual maintenance of this beautiful place that we charge the foundation with caring for, should require that any development plans that alter our park need to be open and transparent to all.

Finally the Billy Austin sidewalk which was built after great efforts, beginning in 1993. The dream of one young wheelchair bound man to connect the Virginia Home to the Maymont gate is still being used on a daily basis by visitors and volunteers to access the park from their home. With a garage and office in this location the Billy Austin sidewalk will cross a street and present a view of a garage.

Finally, these recent expansion plans have opened another conversation about the location of boundary lines. Where is Maymont? Where is Byrd Park? The Dooley's in their generosity failed to make that clear or perhaps they didn't care about the distinction. Perhaps they had fewer lawyers. Perhaps, I don't care about these lines either. Maymont Park is, a City Park for whom we, the citizens of this city, created a not for profit foundation to oversee its operation. A year ago Maymont Park or the foundation or some related entity bought a house in my neighborhood. My neighbors wonder why. I am sure that the intentions must be good, but when homes are being purchased by an entity over which you have no say or recourse, it is scary to homeowners. Imagine any large organization, benign or otherwise buying homes or building garages in other city neighborhoods, your neighborhood. People would express concern, to say the least. In Maymont/Riverview we are concerned too. As a neighborhood we enjoy living next door to Maymont Park, though it often involves some effort, on our parts'. I feel that this construction is crossing a line.

I am writing today to voice my opposition to the proposed horticulture building/maintenance facility and fueling station that is to be located on the curve just outside the historical entrance to Maymont Park on Hampton Street in our residential neighborhood.

There are several reasons that the proposed location is not suitable for such a facility, and why I urge you to vote against the plan before you.

The watershed view of Maymont Park from Hampton Street, where the Foundation has proposed building this structure, is a historical view, one that Sallie Dooley "became enchanted with and asked her husband to buy the land to build her a home on top of the hill."

This view is one that residents on Hampton Street, visitors entering the park from Hampton, and residents of the city who access Maymont through Byrd Park will no longer have should this plan be approved. This view cannot be replaced or restored once a structure has been built here; it should be protected, and great care taken to preserve it. The proposed site is currently open, a beautiful green space; a space that is used by those visiting Byrd park and by residents of the Virginia Home that accesses Maymont from the Billy Austin sidewalk that runs directly through this area.

My neighbors on Hampton Street have enjoyed this unobstructed watershed view for 50+ years. The proposed site is currently not a part of the Maymont park boundary. It is unclear whether Maymont has the authority to build here or use this area that is currently a part of Byrd Park. The proposed site for this building is destructive at best, and is not in keeping with the intention of the Dooley's.

I understand that the Maymont Foundation would like to have a new area to house its horticulture volunteers, some maintenance vehicles and to have a separate fueling station, but this site is not where it should be. This proposal was not shared with the Maymont community or its residents until after plans were already underway and specifications had already been prepared. Neighbors on Hampton Street should not have their view destroyed nor should our community be forced to see maintenance vehicles, fuel delivery vehicles and staff coming to and from this part of our neighborhood that we currently enjoy for its natural beauty and for daily walks, hikes, and biking.

I am sure a more suitable site can be found in what is currently Maymont Park's boundaries. I suggest that the Maymont foundation select a site that will not obstruct a watershed view, and instead find a space that is well shielded from the park's natural vistas and views; a site that will not obscure or take away from an otherwise peaceful and pastoral setting.

Dear Planning Commission Members,

I am writing to you today in opposition of the proposed location for Maymont's Maintenance and Horticulture buildings.

I have enjoyed living in the Maymont neighborhood for almost 20 years. I visit Maymont Park on a regular basis. I walk, drive, bike, rollerblade or even cross country ski down the hill on Hampton Street almost daily. I have many reasons for opposing this location.

- 1. **Viewshed** This location is the "gateway" to the park as you approach from the north on Hampton Street. The view is magnificent, rolling hills stretch towards the the south and west, with old growth trees dotting the pastoral setting. Parks should uphold the responsibility of preserving such rare and special gifts, rather than destroying them.
- 2. **Neighborhood Impact** The proposed maintenance shed will be the fueling station for the parks vehicles. There will be large fuel trucks accessing via a new curb cut. There will be noise. There will be traffic. And this may also impose a safety issue for pedestrians and bicyclists who are either accessing the park or the trails just beyond along the river.
- 3. **Functionality** Architectural renderings always make things look pretty. Nice geometric shapes artfully aligned. Now picture realty, maintenance vehicles, trucks, golf carts both old and new, some garaged and some not. Not so pretty.
- 4. **Transparency** Maymont's process for engaging neighbors has not been without issue. When home owners who live directly across the street from the proposed location do not receive notification, let alone many individuals in a particular neighborhood, including myself, there comes the question of how and why? A presentation was given, some were contacted but not until the proposed location was already chosen. How come there was no involvement prior to?
- 5.**Property Ownership** According to Councilman Parker Agelasto, there remains the question as to who owns the land? This property is on the other side of the park fence, where does Maymont end and Byrd Park begin?

It is not often I plead a case to fellow boards and commissions. Under this circumstance I feel I must let my point of view, shared by many other concerned neighbors in the Maymont community, be known. I thank you for your time and consideration.

I am writing to ask that The City of Richmond Planning Commission oppose the request from The Maymont Foundation "Horticultural Project".

I have lived on Hampton Street for 50 plus years. This is a beautiful residential area, with Hampton Street being a main thoroughfare to getting to our homes and Maymont Park. The site in which the proposed plans are for is not suitable for a maintenance facility containing fuel pumps, high truck traffic, etc. especially in our front yards.

When you have a facility that is housing fuel pumps that is a danger in itself, especially in such close proximity to homes. This is a residential area not a commercial area for maintenance garages or fueling stations. We want to keep our neighborhood safe, beautiful and residential. Needless to say our property values would decline with such a site. It's like putting an "EXXON or TUFFY MUFFLER" in our front yard.

This proposed siting of this project is ill considered of the residents and hundreds of visitors who come to this area yearly. It would diminish the beauty of our neighborhood considerably. While design issues might be solved by conditions or revised proposals, they could not remedy the siting problem, which in itself is distasteful.

Maymont Park has hundreds of acres of land, certainly there could and should be a more suitable location for this facility.

Jeff- I live in the Maymont Park neighborhood. This is my second email to the Planning Commission regarding Maymont's request to move the current boundary that they exist within and encroach on parts of Byrd Park and our Maymont neighborhood in order to build a maintenance facility.

I am shocked at the disregard for the view shed that this building would forever obstruct and alter, and I am confused as to why it would be considered. I disagree with the site selection, and I am at a loss as to how the selection process was determined. I do know that that there are at least 7 other possible locations for this facility that "Maymont" has determined are not as favorable but that exist within the Maymont boundaries and do not encroach on other city parks.

Little regard has been given as to the impact that this location would have on long time residents of Maymont. Not only would the facility obstruct a pristine view that is located just outside of the historic gates of the park, but it would also bring maintenance vehicles and fueling stations to the neighborhood. In addition this site would have unwanted lighting that would affect the natural setting of the area and wildlife. This will most certainly affect neighbors directly across the street from the facility. How does this affect the value of our homes?

Attempts by "Maymont" to engage the neighborhood have been limited to a few meetings where most of my neighbors were not notified in advance, if at all.

I urge you to postpone your decision today while other possible locations can be reviewed and considered.

Dear Mr. Eastman,

I was hoping to make it to the planning commission meeting today to voice my opposition to the planned maintenance facility, but unfortunately I had a work obligation come up that prevents my being there. I am instead sending you this short email in hopes that it will help illuminate how many of my neighbors feel about the planned developments at Maymont Park.

I volunteer for the board of the Maymont Civic League and I am a resident of the Maymont neighborhood. Maymont Park first approached the Maymont Civic League to discuss the plans for this maintenance facility several months ago. Maymont Park representatives attempted to present themselves as though they were soliciting feedback on their development plan and wanted neighborhood input, but it quickly became very evident that the development plans were already decided on and the whole package was a done deal. At the Planning Commissions urging to further engage the neighborhood, Maymont Park then reached out to the neighborhood several more times for "community meetings", but despite large turnouts at every meeting and almost unanimous opposition to their plans, only superficial cosmetic changes to the planned structure were ever proffered. I don't think that any stretch of the imagination could allow one to say that presenting a mostly unaltered plan and rigorously defending it against opposition is "engagement."

Everyone I have spoken with in my neighborhood and many additional people from Randolph and Byrd Park neighborhoods are opposed to the construction of a maintenance facility in this beautiful part of the park. We don't want to see green space irrevocably destroyed. At every single community meeting we asked representatives from Maymont Park: "why this location?" Even a casual observer can see that there is plenty of space in existing buildings at Maymont and that there also seem to be several locations that are tucked behind existing structures (such as the Children's Farm) that would not harm a beautiful view shed. Unfortunately Maymont Park would only tell us that they considered "many different options" and rated them on several scales of cost, suitability, access, etc. However they never shared any additional details with us about the site selection process. I am concerned that Maymont Park's weighting of the attributes and flaws of different sites do not at all align with the larger neighborhood or City's valuation of different sites. I also am concerned that this facility may be spurred on it part by Maymont's planned expansions to exhibitions in current buildings. Expansion plans that we also were not consulted about.

Maymont Park is a beautiful open green park that belongs to the residents of the City of Richmond. However the Maymont Park Foundation's complete disregard for the people surrounding the park have caused many of us to come to the sad conclusion that this park actually belongs to a few wealthy citizens who mainly do not live in Richmond. It feels as though one of our City's greatest assets is being taken from us and we have not pathway to recourse.

I will not be at the Planning Commission meeting today and nor will Patrice Jean, Yvette Coronado, Chris Mercer, Joy Whitney, Seamus Rogers, Cat Ennis, Carol Chaffin, nor my many many other neighbors who oppose this plan. We all have jobs or family obligations that prevent us from attending. But that does not mean that we are not closely observing the outcome of this decision, and hoping that a decision can be reached in favor of preserving green space and insuring a more inclusive approach to planning future expansions at this most loved and treasured city park.
