## VIRGINIA WAR MEMORIAL

The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to officially recognize, honor, and celebrate the Commonwealth of Virginia, Virginia War Memorial, located in Richmond at 621 South Belvidere Street, on the occasion of its 60th Anniversary.

Dedicated to U.S. Military Personnel from Virginia who gave the last full measure of their devotion and supreme sacrifice of their lives in service to our country, the Virginia War Memorial also honors the service of all active and veteran U.S. Military Personnel for their dedication to our nation.

Enshrining the lives of our gallant defenders of peace, the establishment of the Virginia War Memorial was authorized by the Virginia General Assembly in 1950. Construction was completed in 1955 and the Memorial was dedicated on February 29, 1956. Since that time, there have been a number of updates and renovations to the Virginia War Memorial, which now holds regular educational programs, exhibits, seminars and events.

Considered to be one of the finest state memorials for veterans in our nation, the Virginia War Memorial facility currently includes a Hall of Honor Auditorium, Visitors Center, Shrine of Memory, Salute to Virginia Veterans, collection of historic artifacts, research library, and a gift shop. Of extreme importance to this effort is the work of board members, staff, volunteers and supporters who work tirelessly on its behalf.

Originally conceived to honor Virginians killed in the line of duty during World War II, the Memorial now memorializes the lives of U.S. Military Personnel from Virginia that were taken from us during the following campaigns: World War II (1941-1945), Korean Conflict (1950-1954), Vietnam Conflict (1961-1973), Persian Gulf Conflict (1991-1992), Afghanistan Conflict (2001-Present), and the Iraq Conflict (2003-Present).

In America, government and military service is considered to be among the most noble and important work a person can do and, through their actions, our honorable U.S. Military Personnel have proven their dedication to the principles and creed written into the founding documents of our great nation, in that our individual destinies and that of our families, communities, city, state and country include not only the aspiration of our federal constitutional republic but the support and success of its government and all its residents in realizing the fulfillment of its promise.

**NOW THEREFORE**, Richmond City Council does hereby officially recognize, honor, and celebrate the Virginia War Memorial on the occasion of its 60th Anniversary; invites everyone to visit its hallowed halls; and, brings this to the attention of all our grateful residents.
