THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Chapter 2, Article V, Division 1 of the Code of the City of Richmond (2015) be and is hereby amended and reordained by **adding therein a new** section numbered 2-763 as follows:

**Sec. 2-763. Chief Administrative Officer to make certain appointments.**

The Chief Administrative Officer shall be responsible for designating the City’s technical representative and alternate technical representative on the Technical Advisory Committee of the Richmond Area Metropolitan Planning Organization.

### ORDINANCE/RESOLUTION SUMMARY

Patron requests that an ordinance be drafted for City Council's consideration that authorizes the City's Chief Administrative Officer to appoint the technical representative and alternate representatives to the Technical Advisory Committee of the Transportation Planning Organization (TPO), formerly called the Metropolitan Planning Organization (MPO) prior to its re-organization.

### BACKGROUND

This legislation reflects the new make-up of the TPO in which members of the Technical Advisory Committee (TAC) are no longer members of the TPO.

Currently, City Council appoints a representative and an alternate representative to the TAC of the TPO. Those representatives are typically employees of the City Administration with technical expertise in transportation planning. This legislation authorizes the CAO to appoint

these technical representatives in future, on behalf of the City.
