## CHAMBER EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

President Michelle Mosby called the meeting to order and presided. Upon the President's request, Candice Reid, Deputy City Clerk, provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines and conduct during the meeting.

## APPOINTMENTS/REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

## AWARDS AND PRESENTATIONS

All members of Council and Mayor Dwight C. Jones recognized Dr. Donald R. Stern, Director – Virginia Department of Health Richmond City Health District, on his retirement after 30 years of service in the public health field. Dr. Stern expressed his appreciation for the recognition.

President Michelle Mosby, on behalf of City Council, and Mayor Dwight C. Jones, proclaimed the first week of March 2016 as Richmond Women in Construction Week and recognized the National Association of Women in Construction: Richmond Chapter 141.

President Michelle Mosby and Councilor Cynthia Newbille, on behalf of City Council, and Mayor Dwight C. Jones, proclaimed the month of March 2016 as Richmond Multiple Myeloma Cancer

Awareness Month. A. Regina Leftwich, Family Services Worker – Department of Social Services, accepted the proclamation.

Councilor Parker Agelasto, on behalf of City Council, recognized Julie Langan, Director – Virginia Department of Historic Resources, and members of Friends of William Byrd Park, the Carillon Civic Association and the Byrd Park Court Neighborhood for their hard work and dedication toward getting these areas listed on the Virginia Department of Historic Resources Virginia Landmarks Register. Sharon Hill, President – Friends of William Byrd Park, thanked Council for the recognition. Julie Langan informed Council that the historic preservation movement is celebrating fifty years in 2016 with the passage of the National Historic Preservation Act.

Councilor Ellen Robertson, on behalf of City Council, recognized the 50<sup>th</sup> anniversary of the Metropolitan Junior Baseball League (MJBL). Councilor Robertson also recognized Christopher Armstrong and Rahsaan Wigfall for their outstanding service as volunteer coaches within the program. Mr. Armstrong, Mr. Wigfall and William Forrester, Jr., Executive Director – MJBL, accepted the recognitions and thanked Council for its continued support of the MJBL.

Mayor Dwight C. Jones informed Council and citizens of the city's efforts to fight poverty and provided remarks relating to the progress of community wealth building. Dr. Thad Williamson, Director – Office of the Community Wealth Building, provided information relating to the system of metrics being used to chart the progress of reducing poverty within the city.

## CITIZEN COMMENT

*Jennifer Ramachandran* expressed concern regarding the condition of Richmond Public Schools' (RPS) classrooms and how they may affect students and teachers.

*Keri Treadway* informed Council that teacher salaries have been frozen for approximately a decade and, due to inflation, net incomes are fifteen percent lower.

*Chris Lombardi* addressed Council stating that education should be a top priority due to facility neglect and poor employee investment.

*Aaron Garber* requested that Council provide full funding of the RPS budget as the compression of salary steps gets worse each year.

**Brennan Ryan** stated that funding the RPS budget is important to grow the city's middle class citizenry and a strong education system benefits one hundred percent of the city.

**Ansley Perkins** requested that the city equalize its school facilities and stated that, if the city was a better steward of its tax revenue and invested in school facilities each year, the crisis for RPS would be less severe.

*Melvin Jones, Jr.* thanked Council and city agencies for their hard work in ensuring that the construction of a Maggie Walker statue comes to fruition.

## Councilor Parker Agelasto inquired if the right-of-way legislation before Council constitutes all city acquisitions or if additional legislation is forthcoming.

John Burturla, Interim Deputy Chief Administrative Officer for Operations, stated that eighty-four properties were impacted by the Jahnke Road project and the legislation before Council represents seven properties that the city has been unable to obtain through settlement. Mr. Burturla stated that the additional seventy-seven properties have been resolved satisfactorily and there should not be additional legislation before Council in reference to the project.

Councilor Kathy Graziano thanked citizens for attending the 4<sup>th</sup> District meeting and voicing opinions on the baseball stadium and the future of the Boulevard site. Councilor Graziano also thanked citizens for being patient with the city's leaf collection.

Councilor Samuels stated that the Rosedale Civic Association quarterly meeting would be on Tuesday, March 1<sup>st</sup>, at 7:00 p.m., at The Hermitage, 1600 Westwood Avenue.
