Richmond City Council met in the Council Chamber on Monday, March 28, 2016, at 6:03

p.m.

Invocation was offered by Pastor Tyrone Nelson, Sixth Mt. Zion Baptist Church, 14 W. Duval Street, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

CHAMBER EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

President Michelle Mosby called the meeting to order and presided. Upon the President's request, Candice Reid, Deputy City Clerk, provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines and conduct during the meeting.

ELECTRONIC PARTICIPATION

President Michelle Mosby stated that, pursuant to Section 2.2-3708.1 of the Code of Virginia, Councilor Parker Agelasto requested to participate in the meeting electronically due to previously planned travel to Florida.

Councilor Jonathan Baliles moved to allow Councilor Parker Agelasto to participate in the meeting telephonically. The motion was seconded and **approved**: Ayes 8, Baliles, Graziano, Samuels, Robertson, Trammell, Newbille, Hilbert, Mosby. Noes, None.

Councilor Agelasto joined the meeting via phone.

APPOINTMENTS/REAPPOINTMENTS

There were no appointment/reappointment items for consideration.

AWARDS AND PRESENTATIONS

Councilor Ellen Robertson, President Michelle Mosby, on behalf of Richmond City Council, and Selena Cuffee-Glenn, Chief Administrative Officer, on behalf of Mayor Dwight C. Jones, proclaimed the month of April 2016 as Richmond Child Abuse Prevention Month. Ian Danielsen, Greater Richmond SCAN, accepted the proclamation.

Councilwoman Reva Trammell and President Michelle Mosby, on behalf of Richmond City Council, recognized, honored and celebrated Michael L. Berry, Commissioner of the Metropolitan Junior Baseball League – Virginia League, for his outstanding service to the youth of the city of Richmond. Mr. Berry accepted the recognition award.

Councilwoman Reva Trammell and President Michelle Mosby, on behalf of Richmond City Council, and Jean Capel, City Clerk, recognized Karl Johnson for his service to the 8th District community. Mr. Johnson thanked city officials for the recognition.

Councilwoman Reva Trammell, President Michelle Mosby, on behalf of Richmond City Council, and Selena Cuffee-Glen, Chief Administrative Officer, on behalf of Mayor Dwight C. Jones, recognized Darlene Mallory, Executive Coordinator of the Richmond Clean City Commission, for her service to the community. Ms. Mallory thanked city officials for the recognition.

Councilor Jonathan Baliles announced that March 28th marks the 28th Anniversary of Dick Harman broadcasting Richmond City Council formal meetings. He stated that, during Mr. Harman's 28 years, he has attended over six hundred meetings missing only two.

CITIZEN COMMENT

Betty Squire, honorary member of Engine Company Number 9 and Associates (E9), provided the Council with information regarding the establishment of E9 and stated that 2016 marks the 70th Anniversary of the hiring of the first four African-American police officers and the first African-American female officer. Ms. Squire invited the Council to a special celebration paying tribute to African-American law enforcement officers on Saturday, April 30th, at 6:00 p.m., at the Hilton Downtown located at 501 E. Broad Street. She also stated that she may be contacted at (804) 347-5289 or Firefighter Thomas Williams may be contacted at (804) 382-3644 for additional information regarding the event.

Lana Rochelle Turnage, Richmond Public Schools (RPS) teacher, addressed the Council regarding fully funding Richmond Public Schools, stating that RPS students deserve high quality learning environments and competent educators who are not forced to flee to other school systems just to make a decent living.

Heather Crislip, parent of two children in RPS, addressed Council regarding funding for Richmond Public Schools, stating that their experience at RPS has been fantastic and that she is very concerned that the pay grade doesn't reward teachers' value thus placing the whole system at tremendous risk of losing great educators.

Kathryn M. Roseberry, RPS teacher, addressed Council suggesting the use of funding for Dove Elementary School, the new community center and postponing the renovation of the court building, which equal the \$18 million dollars needed to fund the RPS proposed budget increase. Ms. Roseberry advised the Council that she supports Ord. 2016-092 which provides additional revenue to RPS operations and facilities.

A copy of the information provided has been filed.

Phillip Ricks, RPS basketball coach and custodian, addressed Council regarding funding for Richmond Public Schools. Mr. Ricks thanked the Council for all they do for the city.

Councilwoman Reva Trammell expressed appreciation to Mr. Ricks.

Emily Walker, a pre-school exceptional education teacher at Martin Luther King, Jr. (MLK) Early Learning Center, addressed Council regarding funding for Richmond Public Schools. Ms. Walker stated that she is a first year teacher in a new school without a desk or printer paper and she and other teachers have had to spend their own money on needed resources.

Opposition

Ernest Bush spoke in opposition of the proposed legislation stating that if this project is approved the access to the rear of his property will be restricted and requested this item be removed from the consent agenda and tabled for another day.

Support

Charlene Baylor spoke in support of the proposed legislation stating that the Carver community loves the fact that the proposed project will eliminate blighted property in the area and parking will be provided for residents.

Doug Kleffner, Architect, Johannas Design Group, spoke in support of the proposed legislation stating that the project will provide single family home, parking for the residents, street scape and trees.

Sam Forest spoke in support of the proposed legislation stating that he has lived in Carver area for twenty-nine years and has known Zarina Fazaldin for approximately eight years. He also stated that he supports what she is doing for the area and urged Council to do the same.

Florence Breedlove spoke in support of the proposed legislation stating that the project has brightened up the community and brought neighbors together. She asked the Council to approve the project.

Zarina Fazaldin spoke in support of the proposed legislation and encouraged Council to approve the project because it will be excellent for the Carver area. She stated that, as the developer of the project, she has the support from the community and other landlords, by way of letters and emails to the Planning Commission. Ms. Fazaldin answered questions from the Council.

Councilor Charles Samuels stated that it is nice to see that the speakers' definition of community is inclusive where they stick together for the common good and that he is excited that the proposed project includes single family homes. He also stated that he hope his colleagues support the project.

Opposition

John Buturla, Interim Deputy Chief Administrative Officer – Operations, spoke in opposition of the proposed legislation stating that the ordinance, as written, is one that city administration could not support at this time.

Vice President Chris Hilbert stated that Council's working relationship with city administration has proven challenging in the past; consequently, Council is forced, in this instance, to choose between meeting budget obligations and promoting transparency.

Councilor Jonathan Baliles asked city administration if it is amenable to organizing a working group to determine whether or not completing the proposed project is possible in the next month or so see if the project is possible.

Charles Todd, Interim Director of Information Technology, stated that the project is doable in terms of technology, the challenge agencies will face is the different ways information is kept today. *Mr.* Todd also stated that to do this, a clerical assistance and a writing assistant is needed, along with many staff hours to mass assemble, publish and update the information.

Selena Cuffee-Glenn, Chief Administrative Officer, stated that she would support working together to come up with a timeline and a plan of action for the proposed legislation.

Councilor Cynthia Newbille suggested including students from Virginia Commonwealth University, Virginia Union University and University of Richmond as part of the group.

Councilor Baliles moved to continue Ord. 2015-192 to Monday, June 27, 2016 which was seconded and unanimously approved.
