THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 12-120 of the Code of the City of Richmond (2015) be and is hereby

amended and reordained as follows:

Sec. 12-120. Rates and discounts for parking facilities operated by the City.

to Code of Virginia, § 15.2-105, any person failing to pay any account due the City under this

section on or before its due date, shall incur a penalty thereon of ten dollars or an amount not exceeding ten percent, which shall be imposed and collected as provided in Code of Virginia, § 15.2-105. Special event and night rates apply Monday through Friday from 6:00 p.m. to 6:00 a.m. and all day Saturday and Sunday. The Director of Public Works shall fix the hours of operation for each facility in accordance with this section. In cases for which this section establishes a range of fees or rates, the Chief Administrative Officer is authorized to change such fees or rates in the Chief Administrative Officer's discretion within such range.
