PURPOSE

To authorize the Chief Administrative Officer to accept funds in the amount of \$552,000 from the Virginia Department of Environmental Quality.

SUMMARY & RECOMMENDATION

The Department of Public Utilities in December 2014 secured approval for a Virginia Department of Environmental Quality Stormwater Local Assistance Fund (SLAF) matching grant to help fund the City's proposed Rattlesnake Creek Stream Restoration Project. This stream restoration project is being constructed as part of The City's efforts to satisfy Chesapeake Bay TMDL (Total Maximum Daily Load) requirements as mandated by the U.S. Environmental Protection Agency and the City of Richmond's Municipal Separate Storm Sewer (MS4) permit (General Permit No.: VAR040005) issued by the Virginia Department of Environmental Quality. The Chesapeake Bay TMDL establishes pollution reduction goals for phosphorus, nitrogen and sediment for municipalities located within the Chesapeake Bay watershed in an effort to improve water quality in the bay and the region's streams, creeks and rivers.

The City will receive additional revenue of \$552,000 in the form of a Stormwater Local Assistance Fund matching grant from the Virginia Department of Environmental Quality in support of the Rattlesnake Creek Stream Restoration Project. The City's Stormwater Utility will contribute \$552,000 in matching funds for the project. The Department of Public Utilities will utilize the Virginia Department of Environmental Quality Stormwater Local Assistance Fund (SLAF) matching grant to help fund The City's proposed Rattlesnake Creek Stream Restoration Project. The total funding package of \$1,104,000 during calendar years 2016 & 2017 for the

completion of the project. This stream restoration project is being constructed as part of the City's efforts to satisfy Chesapeake Bay TMDL (Total Maximum Daily Load) requirements.

The Department of Public Utilities recommends adoption of this ordinance.

Master Plan

The Master Plan recommends Single Family Low Density land use along Rattlesnake Creek and the western portion of Weyburn Road.

Zoning & Land Use

The majority of the land along the western portion of Weyburn Road is zoned R-2, Single Family Residential District.
