ORDINANCE/RESOLUTION SUMMARY

The Patron requests a resolution that expresses the intent of City Council:

- The Chief Administrative Officer shall provide City Council with a quarterly report that compares the adopted appropriations for each agency with projected actual expenditures. This report shall be provided no later than the first day of the first month of the next fiscal quarter.
- Any budget ordinance introduced for the purpose of reconciling adopted appropriations with projected actual expenditures shall be introduced no later than the first day of the first month of the next fiscal quarter.
- The ordinance shall be effective on July 1, 2017.

BACKGROUND

Summary: This resolution expresses the intent of City Council that a systematic program to continually monitor city expenditures against the adopted appropriations, and make needed adjustments quarterly shall be established.

As part of the 'Well-managed Government' strategy the administration currently makes adjustments to the budget "...to more closely align agency budgets with their projected expenditure..."

- Such adjustments were made in FY 2012, FY 2013, FY 2014, and FY 2015 in third Quarter reappropriation papers. (FY 2014 and FY 2015 Ordinances are attached.)
- These third quarter adjustment are introduced too late in the fiscal year for City Council to have any meaningful input on the final disposition.
- Continually monitoring and reporting on City expenditures in comparison to adopted appropriations, will strengthen the City's financial management.
