

PURPOSE: To accept funds from Richmond Retirement System and appropriate such funds to the City of Richmond, City Hall Renovations Project CIP #500438 for the purpose of funding continued renovations in the City Hall Renovations Program.

**REASON:** The City completed renovations for the Richmond Retirement System at 730 E. Broad Street as part of the first phase of the City Hall Renovation Program and Richmond Retirement has reimbursed the City for the agreed renovations.

**RECOMMENDATION:** Approval is recommended by the City Administration

#### **BACKGROUND:**

The City recognized the need to renovate areas within City Hall for better customer service, patron environment, consolidate department staff and improve functionality. The first phase of the City Hall Renovation Program was to relocate all City Attorney offices located around the city to the City Hall 4<sup>th</sup> Floor and renovate City Hall Lobby. In order to accomplish the 4<sup>th</sup> Floor Renovation, the Department of Parks & Recreation was relocated to Admiral Street, Press Secretary Office was relocated to the City Hall 11<sup>th</sup> Floor and Richmond Retirement was relocated to 730 E. Broad Street.

Under the terms of the Agreement to relocate the Richmond Retirement System, the City would build out the tenant upfit space at 730 E. Broad Street, 9<sup>th</sup> Floor to meet the needs of RRS and the costs for construction would be reimbursed to the City for a total of \$559,343.13. Under the terms of this Agreement, the City has received the total sum of \$559,343.13 and those funds are needed to support Phase III of the City Hall Renovation Program.

FISCAL IMPACT/COST: \$559,343.13 will be appropriated to the FY 17 CIP Budget.
