I had a chance to review the plans for the new single-family dwelling at 2808 1/2 East Leigh Street and I wanted to pass along the comments that I will share with the Secretary to CAR and the CAR members this week via a letter. Overall, the new house is a substantial improvement to the block. I only recommend a few small adjustments to help the house fit better into the block and match the residential quality standards we are seeing with new construction occurring in the neighborhood.

- 1) The foundation should be brick. Most of the new homes being built in the area have brick foundations.
- 2) The front door looks suburban with the small window located at the top of the door. A door with a half-window and split recessed panels would match the doors being installed on the new homes in the 600 block of North 29th Street.
- 3) The cornice looks too small in scale on the front elevation. The overall height of the cornice should be increased by 6" or 12" to help give it more presence on the front elevation.
