# Monday, November 14, 2016 4:00 PM Council Chamber, 2nd Floor - City Hall

Richmond City Council convened in Informal Session on Monday, November 14, 2016, in the Council Chamber located on the second floor of City Hall, 900 East Broad Street.

Council President Michelle Mosby called the meeting to order at 4:18 p.m. and presided.

Upon the President's request, Assistant City Clerk Lisa Braxton provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency.

# Reedy Creek Coalition (RCC)

Bill Shanabruch, RCC member, presented Council with information regarding RCC concerns with the proposed Reedy Creek stream restoration project. A copy of the presentation has been filed.

John Buturla, interim deputy chief administrative officer – Operations, and Bob Steidel, Public Utilities director, were available to answer questions regarding the proposed project.

Drew Gould, Timmons Group public land development and community revitalization director, stated that his organization actually supports the proposed Reedy Creek stream restoration project even though information was provided in the RCC presentation that suggested otherwise.

David Paylor, Virginia Department of Environmental Quality (DEQ) director, addressed Council and stated that grant funding for the restoration project could only be utilized for the specified area noted in the application and that the city would need to reapply if a different area was preferred. Melanie Davenport, DEQ water permitting division director, was also available to answer questions regarding the overall Virginia Chesapeake Bay nutrient and sediment reduction goals for localities. Rosemary Green, Public Utilities deputy director, also provided Council with information regarding the restoration project. A copy of the information has been filed.

Councilor Parker Agelasto expressed several concerns regarding the restoration proposal and stated that the grant should be rejected; he suggested deferring the project until community input had been vetted for inclusion

Councilor Cynthia Newbille suggested that the proposed legislation (Ord. 2016-217) for the Reedy Creek stream restoration project be amended to allow for incorporation of RCC recommendations and a project derailment clause if no agreement between stakeholders is met.

# Comprehensive Annual Financial Report (CAFR)

Lenora Reid, deputy chief administrative officer – Finance and Administration, provided Council with an update regarding the FY 2015 CAFR; she reported its completion and that (i) the city received a clean (unmodified) opinion, (ii) the qualification from the FY 2014 CAFR audit due to capital assets was removed and (iii) there was growth in the city's unassigned fund balance.

Angela Dunlap, Grant Thornton audit services partner, presented Council with information regarding their findings of the fiscal year 2015 CAFR audit. A copy of the information has been filed.

Ms. Reid stated that city administration has prepared a plan of action to address internal control matters concerning material weaknesses and significant deficiencies reported in the audit.

Due to time constraints, the leaf collection program presentation and the adjacent property notice update discussion item were rescheduled for the December 5, 2016 Organizational Development Standing Committee meeting.
