Councilor Parker Agelasto stated that he was advised that a vote from Council was required before the City Attorney could release his legal opinion to the city administration regarding the cash bonuses granted to city employees by former Mayor Dwight Jones; therefore, he would like Council to consider a formal vote on the matter.

Councilor Parker Agelasto moved to request that the City Attorney provide its legal opinion to the city administration regarding the legality of the bonuses that were approved by former Mayor Dwight C. Jones.

In response to a question from Vice President Cynthia Newbille, City Attorney Allen Jackson stated that he was precluded from providing the legal opinion without the consent of Council.

# The motion was seconded unanimously approved.

Councilor Kim Gray stated that she would like Council to consider a review of the guidelines for providing and computing severance payouts to separating city employees, and that she is in the process of initiating a review of the guidelines.
