Annual Mayoral Report on Poverty Reduction and Community Wealth Building Initiatives

Mayor Levar Stoney provided an overview of the goals of the Office of Community Wealth Building under the leadership of Director Reginald Gordon. Mayor Stoney stated that the Office of Community Wealth Building plans to ease barriers so that, annually, citizens successfully reach a thriving level of economic stability. Mayor Stoney acknowledged former mayor Dwight C. Jones, Councilor Ellen Robertson and Thad Williamson for their efforts to reduce poverty.

Reginald Gordon thanked City Council and Chief Administrative Officer Selena Cuffee-Glenn for their support of initiatives to reduce poverty in the city and provided an overview of the purpose and goals of the Office of Community Wealth Building.

A copy of the information provided has been filed.

Councilor Ellen Robertson commended Mr. Gordon and others for the progress made to reduce poverty in the city, and asked members of the Maggie L. Walker Initiative Citizens Advisory Board and Office of Community Wealth Building staff to stand for recognition.

Mr. Gordon highlighted the direct impact of poverty, the shared vision for the community, and steps needed to implement the vision to reduce poverty. Mr. Gordon asked James Davis, resident of Richmond Redevelopment and Housing Authority's, Fairfield Court, to share his story.

James Davis spoke on the challenges he experienced and observed in the city's low income housing neighborhoods. Mr. Davis stated that his goal was to educate the residents of public housing to increase knowledge and decrease poverty. Mr. Davis thanked Mr. Gordon and the Center for Workforce Innovation's staff for their support in his life and in the lives of his children.

Mayor Stoney highlighted city administration's commitments to reduce poverty; he a copy of his Annual Report on Poverty Reduction and Community Wealth Building Initiatives.

President Chris Hilbert and Vice President Cynthia Newbille thanked all agencies and various individuals for their support in making Richmond a city of economic growth.

The meeting recessed at 6:44 p.m., due to a brief medical emergency.

The meeting reconvened at 6:55 p.m., Councilor Kim Gray was excused.

AWARDS AND PRESENTATIONS

City Council proclaimed the month of February 2017 as Richmond African American History Month. All members of Council and Mayor Levar M. Stoney presented the proclamation to the Honorable Delores McQuinn, member of the Virginia House of Delegates and Chairman of the Richmond City Council Slave Trail Commission. Delegate McQuinn encouraged residents to join a cleanup of the Evergreen and East End Cemeteries, scheduled for Saturday, March 11th, at 9:00 a.m.

City Council proclaimed the month of March 2017 as Richmond Women's History Month. Shirley Crawford along with other co-founders of a local organization accepted the proclamation.

City Council and Mayor Levar M. Stoney recognized the Department of Fire and Emergency Services' Engine Company 11 B-Shift and Station 10 A-Shift for delivering emergency management and response in helping protect the city's residents in times of crisis or need. Members of Engine Company 11 B-Shirt and Station 10 A-Shift received the proclamation. Interim Fire Chief David Daniels thanked Council and the mayor for the proclamation.

Mayor Levar M. Stoney recognized several black-owned restaurant owners and encouraged residents to support minority owned eateries during Black Restaurant Week beginning March 6, 2017 through March 12, 2017. Owners of Mama J's Kitchen and Southern Kitchen accepted the proclamation.

Councilor Kim Gray reentered the meeting and was seated.

CITIZEN COMMENT

Lucas Fritz, owner of the Broadberry, provided copies of the alleyway located in the 2700 block of West Broad Street. Mr. Fritz stated that the poor condition of the alleyway negatively impacts surrounding businesses and visitors' impressions of the city.

A copy of the information provided has been filed.

Councilor Kim Gray thanked Mr. Fritz and stated that the current state of the alleyway does negatively impact surrounding businesses; she emphasized that funding for the alley repairs should be considered during the upcoming budget discussions.

Robert Gordon, chairman of the Church Hill Association's Land Use and Historic Preservation Committee, addressed Council regarding the proposed demolition of the trolley barn for the Glenwood Ridge Apartments project. Mr. Gordon reported that the Church Hill Association opposed the proposed project; he stated that the development could set a precedent and create a condensed concentration of low-income developments in one particular area. Mr. Gordon indicated that the area residents were not notified of the proposed project.

Vice President Cynthia Newbille invited Mr. Gordon to participate in discussions regarding the proposed project on March 30th, at the Powhatan Community Center, 5051 Northampton Street.

Roderyck Bullock thanked Vice President Cynthia Newbille for her assistance in helping him obtain transportation for a family member. Mr. Bullock recounted incidents of unacceptable service with the Greater Richmond Transit Company (GRTC) CARE Van service and urged Council to take action to resolve the issues.

Councilwoman Reva Trammell thanked Mr. Bullock and stated that she has received calls from constituents regarding the GRTC CARE Van services. Councilwoman Trammell stated that Council needs to take immediate action to protect the city's CARE Van patrons.

Councilor Ellen Robertson stated that the Land Use, Housing and Transportation Standing Committee will discuss the service issues at its March 21st meeting, at 3:00 p.m., and that she wanted to meet with city administration, GRTC personnel and the GRTC Board of Directors to discuss the issues prior to the March 21st standing committee meeting.

Vice President Cynthia Newbille invited Mr. Bullock to share his concerns at the March 21st Land Use, Housing and Transportation Standing Committee meeting.

Councilor Kim Gray thanked Mr. Bullock for bringing the service issues to the attention of Council and advised Mr. Bullock to feel free to contact her for the transportation needs of his family member; she also informed Mr. Bullock that Council recently approved legislation that will provide patrons with an on-demand transportation option through the use of a third party transportation provider.

Benjamin Lewis addressed Council regarding increased crime in the city's Northside; he recalled incidents where his home and his neighbors' homes were burglarized, and incidents where his vehicles were stolen or damaged. Mr. Lewis stated that he was recently advised that many of the crimes were committed by juveniles and that it is important for the city's leaders to create stricter guidelines to deter what is described as petty crimes.

Councilwoman Reva Trammell stated that home invasions and car thefts were on the rise and that she wanted to discuss the issues at the next Public Safety Standing Committee meeting, scheduled for Tuesday, February 28th, at 5:00 p.m.

It was the consensus of Council to suspend Council's Rules of Procedure to allow an additional citizen to speak during the citizen comment period.

Lester Johnson, owner of Mama J's Kitchen, expressed concern that business owners in the vicinity of the proposed 1st and 2nd Streets buffered bike lane project, were notified of the project approximately one week prior to the day's meeting. Mr. Johnson reported that the proposed project will be discussed in detail at an upcoming meeting on Monday, March 20th, at the Hippodrome Theater, 528 North 2nd Street. He stated that it is extremely important for residents to be informed of proposed projects throughout the city. He urged the city to create guidelines in which business owners and residents are notified of such proposed projects.

Councilor Parker Agelasto commented that a similar situation occurred during another proposed bike lane project and asked for Council's support in creating guidelines to notify the public of these types of projects.

Vice President Cynthia Newbille stated that she supported the proposed project and that she was confident that city administration would discuss design options with area residents before finalizing the project.

ORD. 2017-010

To authorize TRP Roseneath, LLC, to encroach upon the public right-of-way with a proposed outdoor dining area encroachment on the northwest line of Roseneath Road between West Leigh Street and West Moore Street in front of 1500 Roseneath Road, upon certain terms and conditions.

Councilor Kim Gray expressed support for the proposed project stating that the project would be an asset for the community and increase revenue for the city; she indicated that the Scott's Addition Civic Association supported the proposed legislation.

To authorize the special use of the properties known as 1600 West Main Street and 1608 West Main Street for the purpose of authorizing a distillery and the retail sales, wholesale, and distribution of liquor, upon certain terms and conditions.

Vice President Cynthia Newbille stated that the proposed legislation progresses the Creighton Court transformation project.

Councilor Ellen Robertson stated that it was important that notifications of the proposed bike lanes include residents of all neighborhoods that will be impacted.

Councilor Kim Gray stated that she was willing to collaborate with Councilor Robertson to ensure that all impacted residents are notified.

President Chris Hilbert disclosed that the resolution would designate certain properties on North 31st Street as a revitalization area pursuant to Virginia Code Section 36-55.30:2 to facilitate the financing by his employer, the Virginia Housing Development Authority, of a project to build up to 250 new mixed income housing units.

There were no further comments or discussions and **the Consent Agenda was unanimously adopted with the exception of RES. 2017-R011, which was also adopted:** Ayes 8, Jones, Robertson, Larson, Agelasto, Gray, Trammell, Addison, Newbille. Noes 0, Abstentions 1, Hilbert (C.O.I).

REGULAR AGENDA

To rename the building located at 900 East Broad Street and known as "City Hall" as "L. Douglas Wilder City Hall."

Councilwoman Reva Trammell advised Council of her decision to withdraw ORD. 2015-033 stating that she was informed by former Virginia Governor and Mayor L. Douglas Wilder that he did not want City Hall to be renamed in his honor.

Councilor Michael Jones stated that former Governor L. Douglas Wilder made history in being elected the first ever African American governor and that the city should be willing to honor and recognize the accomplishment.

To authorize the Chief Administrative Officer to accept funds in the amount of \$3,800,000.00 from the Virginia Department of Transportation; to amend the Fiscal Year 2016-2017 Special Fund Budget by creating a new special fund for the Department of Economic and Community Development called the Richmond Transit Network Plan Implementation Special Fund; and to appropriate the grant funds received to the Fiscal Year 2016-2017 Special Fund Budget by increasing estimated revenues and the amount appropriated to the Department of Economic and Community Development's Richmond Transit Network Plan Implementation Special Fund by \$3,800,000.00 for the purpose of providing funding for technical work, marketing, planning, project management, and public outreach initiatives related to the implementation of the Richmond Transit Network Plan project.

Amy Inman, administrator of multimodal transportation, Economic and Community Development stated the funds would be appropriated to a special fund for the implementation of the Richmond Transit Network Plan project.

Support

Stewart Schwartz, Partnership for Smarter Growth founder, spoke in support of the proposed legislation stating that the funding would move the city closer to the implementation of the Richmond Transit Network Plan.

There were no further comments or discussions and **ORD. 2017-022 was unanimously** adopted.
