Richmond Bicycling Month

Whereas, The Honorable Levar M. Stoney, Mayor of Richmond, and The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia in the United States of America, do hereby unite in solidarity and common purpose to affirm that bicycling is an efficient, economical and environmentally-friendly form of transportation and a fun recreational sport for all ages; and

Whereas, The Richmond community has an active, profound and well-established, bicycling history that dates back to the relatively early advent, adoption and usage of modern-style bicycles in the United States of America, which includes the 1890's establishment of the Lakeside Wheel Club for bike enthusiasts by famed local industrialist, Lewis Ginter; and

Whereas, Richmond has long been distinguished by and acclaimed for its thriving bicycling culture and high commuter rates among its residents; and

Whereas, Some examples of Richmond's bike amenities include it being one of the first cities in North America to install bike racks on its public buses and its placement of a number of municipal bike racks in the city; and

Whereas, In addition, Richmond also has a dedicated bicycle, pedestrian and trails coordinator position within the Richmond Department of Public Works and has established miles of marked bicycle lanes and sharows, with more planned for the future; and

Whereas, Over the years, Richmond has hosted many notable bicycling events, which include the Tour de Trump, Tour DuPont, CapTech Classic, Xterra World Tour, US. Open Cycling Championship, Duathlon World Championships, Capital Classic Annual Bike Race, Virginia State Games Bike Races, and the recent Union Cycliste Internationale World Road Cycling Championships; and

Whereas, Bicycle-friendly communities are known to include residents of increased health, wellbeing, and quality of life; and, bicycles help improve traffic safety and reduce pollution; and

Richmond Asthma Awareness Month

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to recognize Asthma as a critical threat to the life, health and well being of all families living in our community; and

Whereas, A potentially life-threatening disease, Asthma is a chronic long-term inflammatory illness causing constriction of the lungs that can present severe breathing problems; such as breathlessness, wheezing, chest tightness and coughing; and

Whereas, There is currently no known cure for Asthma, for which symptoms can vary in frequency, severity and manifestation and require daily monitoring and management; and

Whereas, It is estimated that more than 5,000 Richmond Residents have Asthma, 70 percent of which are children; and

Whereas, Asthma is reported to be a leading cause of childhood hospitalization and school absenteeism; and

Whereas, The Central Virginia Asthma Coalition is a local entity working to help improve the health and well being of people with asthma; through education, advocacy, and activities; and

Whereas, The United States of America Department of Health and Human Services - Centers for Disease Control and Prevention recognizes the month of May as Asthma Awareness Month to help increase awareness about environmental precautions and preventions of Asthma triggers; and

Whereas, In 1998 the Global Initiative for Asthma established the first Tuesday in May as World Asthma Day, which serves as a kickoff day for Asthma Awareness Month activities in May; and

Whereas, The major goals of these efforts is to improve the lives of people with Asthma by helping them identify and reduce their exposures to environmental triggers at home and school; and

Whereas, An increased awareness of environmental triggers empowers us to help decrease the quantities of severe Asthma attacks and the amount and costs of hospital visits;
