PURPOSE: To pass a resolution to allow the Chief Administrative Officer to apply for a Commonwealth of VA Industrial Revitalization Fund grant on behalf of Better Housing Coalition to undertake the rehabilitation and adaptive reuse of the property located at 3200 West Broad Street.

REASON: Industrial Revitalization Fund awards are available for the strategic redevelopment of vacant and deteriorated industrial properties across the Commonwealth. Only local governments may submit applications for funding. The City of Richmond wishes to apply for \$600,000 of Industrial Revitalization Fund grant funding on behalf of Better Housing Coalition for the rehabilitation and adaptive reuse of a derelict commercial property located at 3200 West Broad Street.

BACKGROUND: Better Housing Coalition, established in 1988, has annual revenues of approximately \$15 million, net assets of \$65 million and employs approximately 75 people. Over

the last 25 years, BHC has developed and invested over \$200 million to serve nearly 10,000 families.

The project is a catalytic adaptive reuse of a derelict commercial property (hotel) at 3200 W Broad Street into a \$46 million mixed-use, mixed-income, multi-family affordable housing community with direct access to multi-modal transportation systems in the Scott's Addition neighborhood.

Requested IRF funding is to be used for rehabilitation and construction of the nearly 50,000 ft<sup>2</sup> of commercial & retail space across two floors, including an affordable childcare center, possible workforce development center and primary care medical office, with potential employment opportunities.

The grant has a 1:1 match requirement which the City of Richmond has allocated \$100,000 of FY17 CDBG to help fulfill. The remainder of the match requirement is fulfilled through a VHDA Community Impact Grant (\$150,000) and private equity (\$1,000,000).

**FISCAL IMPACT / COST:** The City has committed \$100,000 of Community Development Block Grant Funds. No other City funds this fiscal year.

**FISCAL IMPLICATIONS:** The development will increase the City's tax base through the addition of approximately 200 new apartments, and nearly 50,000 square feet of commercial space.

**REVENUE TO CITY:** The City will, upon award and approval, accept and administer funds in their entirety to Better Housing Coalition to reimburse costs incurred for their development located at 3200 West Broad Street.
