(2017-2018), which, if enacted, would be known as the Rehabilitation of Historic Schools Act of 2017, and on May 17, 2017, United States Senator Timothy M. Kaine, for himself and United States Senator Mark R. Warner, introduced Senate Bill 1156, S. 1156, 115th Cong., 1st Sess. (2017-2018), which, if enacted, would be known as the School Infrastructure Modernization Act of 2017, to amend the Internal Revenue Code of 1986 to allow rehabilitation expenditures for public school buildings to qualify for rehabilitation credit; and

ORDINANCE/RESOLUTION SUMMARY

Resolution is to support the School Infrastructure Modernization Act, U.S. Senate Bill 116 (S. 116) and the House of Representative Bill 922 and (H.R. 922).

BACKGROUND

This O&R is to request a resolution to support legislation by U.S. Senator Tim Kaine and U.S. Senator Mark Warner, U.S. Senate 116 known as the School Infrastructure Modernization Act, to amend the Internal Revenue Code of 1986 to allow rehabilitation expenditures for public school buildings to qualify for rehabilitation credit. This resolution is also to support the companion bill, H.R. 922 sponsored by Representative Donald McEachin and Representative Dwight Evans.

On May 17, 2017, Senator Tim Kaine and Senator Mark Warner introduced Senate Bill S.116 to the 115th United States Congress, known as the School Infrastructure Modernization Act, which will amend the federal historic rehabilitation tax credit to

apply to school buildings that continue to operate as schools. Under current law, the credit applies only for buildings renovated to serve a different function than before. This legislation would waive this "prior us" clause for school renovation projects. This legislation would allow school districts with aging infrastructure and tight budgets to partner with private entities to finance renovations that the districts otherwise would not be able to afford. The bill is intended to spur public and private investment in renovating active historic school buildings.

Historic designation requires the structure to be 50 years or older. If this bill were to pass, there are 30 local schools in the City of Richmond that could be eligible for the tax credit. The findings of a Virginia Department of Education Study conducted in 2013 of all schools in the Commonwealth of Virginia showed 45 schools with the age of 30 years and older, with 33 of the 45 schools eligible for historic register designation. Since that study was conducted, 3 of the schools have been newly constructed and renovated reducing the number to 30 schools in the City of Richmond that are over 50 years old with historic register designation.

In Virginia, the Historic Rehabilitation Tax Credit has helped to restore more than 1,200 structures since 1997, and the VDOE 2013 analysis says about 40 percent of the K-12 schools in the Commonwealth, which is about 800, are at least 50 years old.
