The event empowers residents and strengthens neighborhoods by creating an opportunity for families to visit and talk with one another and with civic groups, local officials, firefighters, law enforcement, businesses, and neighborhood organizations.

Local National Night Out events include crime prevention activities ranging from turning on porch lights to block parties and cookouts that include food and games for children.

Held each year on the first Tuesday of August, National Night Out was established in 1984 by the National Association of Town Watch as a program to help build neighborhood unity in fighting crime. The celebration includes participation in all 50 U.S. states, U.S. territories, Canada and U.S. military bases around the world.

Each year numerous local National Night Out events and activities are locally planned in neighborhoods throughout Richmond, these events are great way to meet, talk and play with neighbors and enjoy fun-filled family activities.

Producing successful larger-scale events requires great dedication and includes hundreds of hours of hard work in directing, planning, producing, communicating, advertising, coordinating, and managing, which includes overseeing ongoing and sometimes fluid organizational dynamics, logistics, volunteers, vendors, talent, attendees, health and life safety/security needs, and numerous other critical details. Many times a thankless task, successful events, with their many facets and responsibilities, are typically led and directed by a committed event manager and aided by assistants.

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to declare children to be one of our community's most precious resources; and

Whereas, Fundamental to their success is good education and health, which begins at home with the child and the responsibilities of parents and caregivers in providing early childhood education and ongoing direction, nurturing and support in helping build the social, academic, physical, and intellectual capacities and tools our children need to succeed; and

Whereas, Key to building and maintaining healthy and productive lives is healthy lifestyles, which include healthy eating habits and nutrition; physical health and fitness; mental health; and, cultural, environmental, medical healthcare, and socioeconomic factors; and

Whereas, According to the U. S. Centers for Disease Control and Prevention, rates of U.S. childhood obesity have more than doubled over the past 30 years and there have been significant increases in diagnoses and medication of children for Attention Deficit Hyperactivity Disorder; and

Whereas, During the past 30 years, controversial public school testing and funding cuts have been cited for the elimination of daily physical education and reduction of recess time for public schools children; and

Whereas, In hopes of helping increase the health of public school children, the Partnership for a Walkable America organization established a Walk to School Day initiative in Chicago in 1997, which was later expanded nationally; increased to include the month of October; added on to include bicycling; and, promoted with a Safe Routes to School Program component; and

Whereas, Local event promoters are encouraging public school children ages 5 to 11 who live within a two mile radius of their school to walk or bike to school and have partnered with the following Richmond Public Schools: Woodville Elementary School, Chimborazo Elementary School, Ginter Park Elementary School, J.E.B. Stuart Elementary School, Mary Munford Elementary School, Oak Grove Elementary School, and Fairfield Court Elementary School;
