APPLICATION TO THE VIRGINIA DEPARTMENT OF TRANSPORTA-TION (VDOT) REQUESTING PROJECT FUNDING FROM THE BIEN-

NIAL FY2019-FY2020 FEDERAL TRANSPORTATION ALTERNATIVES

PROGRAM FOR GILLIES CREEK GREENWAY PROJECT

PURPOSE: To authorize the Chief Administrative Officer (CAO) or designee, for and on behalf of the City of Richmond, to formally request funding from VDOT for Gillies Creek Greenway design and construction improvements from Williamsburg Avenue to Jennie Scher Road for FY19 and FY20 of the FY2019-FY2020 federal Transportation Alternatives (TA) Program.

REASON: In accordance with the Commonwealth Transportation Board (CTB), it is required that a supporting resolution and a City Council public hearing of the resolution be held for the application to be considered for awarding of Transportation Alternatives Program (TAP) funds. This year VDOT is requiring a biennial application submittal for fiscal years 2019 and 2020 for Transportation Alternatives Program.

RECOMMENDATION: The Department of Public Works recommends approval.

BACKGROUND: The Transportation Enhancement (TE) program established under 'SAFTEA-LU' was replaced by the Transportation Alternative Program (TAP) with the passage of MAP-21.

Fixing America's Surface Transportation Act or "FAST Act" eliminates the MAP-21 TAP and replaces it with a set-aside of Surface Transportation Block Grant (STBG) program funding for TAP. These set-aside funds include all projects and activities eligible under TAP, encompassing a variety of smaller-scale non-motorized transportation projects such as pedestrian and bicycle facilities, recreational trails, safe routes to school projects, community improvements such as historic preservation and vegetation management, and environmental mitigation related to stormwater and habitat connectivity. There are 10 eligible activities under this program.

The FAST Act requires all TAP projects to be funded through a competitive process. This funding program mandates 20% in matching funds to be supplied by the applicant and the City be responsible for operating and maintenance cost of the TA improvements.

This year VDOT is requiring a biennial application submittal for fiscal years 2019 and 2020 for the Transportation Alternatives Program. This is a change from previous years' application submittals.

From the Riverfront Plan, "The Gillies Creek corridor restrictions make this an advantageous alignment for commencing design and construction of a Gillies Creek Greenway. The objective is to provide a non-street dependent, shared use corridor connecting pedestrians and cyclists from neighborhoods as far away as Oakwood and Montrose with an expeditious route to the Virginia Capital Trail and the James River. This greenway would provide even more connectivity between outlying diverse neighborhoods and the Downriver parcels at Lehigh and Intermediate Wharf, and destinations along the Virginia Capital Trail." The total project cost is estimated at \$3,501,750 to build the greenway from Virginia Capital Trail to the Oakwood neighborhood.

Gillies Creek Greenway Phase I is anticipated to be covered mainly by private parties who may elect to construct the portion of the greenway from the James River / Virginia Capital Trail to Williamsburg Avenue.

Gillies Creek Greenway Phase II (FY 19 TA Application) will involve the design and construction of a 10-foot paved shared use path extending 0.5 miles from Williamsburg Avenue to Government Road. The amount of TA funding requested for FY19 is anticipated to be \$420,000 (80%) of the FY2019 — FY2020 TA Program for Phase II design and construction. A City match (20%) of \$105,000 will be required, if federal funding is approved, for a total Phase II cost estimated at \$525,000.

Gillies Creek Greenway Phase III will involve the design and construction of a 10-foot paved shared use path extending 0.5 miles from Government Road to Jennie Scher Road. The amount of TA funding requested for FY20 is anticipated to be \$420,000 of the FY2019 - FY2020 TA Program. A City match (20%) of \$105,000, if federal funding is approved for FY20, for a total Phase III cost estimated at \$525,000.

Combined Phase II + Phase III project cost is estimated at \$1,050,000. Total \$840,000 (80%) federal TA funds are being requested in FY19 & FY20. This program requires a 20% City match. If federal funding for this project is received, the City will need to budget matching fund in the amount of \$210,000 (FY19- \$105,000 and FY20 - \$105,000) through the upcoming CIP budget.

The TAP application process requires a Council Public Hearing of the Resolution to be held and submitted to VDOT prior to November 1, 2017, the application deadline.

FISCAL IMPACT/COST: If federal funding for this project is received, the City's share will be 20% of the total project cost in the amount of \$210,000 (FY19- \$105,000 and FY20 - \$105,000). The City will need to fund this via future CIP budgets upon federal grant approval.

FISCAL IMPLICATIONS: N: Not adopting this resolution will not allow the project to compete for the Federal Transportation Alternatives funds.

BUDGET AMENDMENT NECESSARY: No.

REVENUE TO CITY: \$840,000 (FY19 - \$420,000; FY20 - \$420,000) if federal TAP Funds are approved by VDOT.
