RVA Education Compact

Discussion of this item took place during Council's consideration of RES. 2017-R050.

MOTION TO AMEND AND VOTE ON PAPER

Councilor Parker Agelasto moved that the resolution entitled:

RES. 2017-R050

To express the Council's support for the "first stage" of an "education compact."

be amended as follows:

Page 2, Line 12

After the word "Superintendent", strike the comma, the text "or their designees", and the comma immediately following the word "designees"

Page 2, Line 18

After the word "by", strike the text "the President of"

Page 3, Line 5

After the words "consent of", strike the text "the President of the Council, the Vice President of"

Page 3, Line 6

After the word "Council", strike the comma, the text "the Chairman of the School Board", and the comma immediately following the word "Board"

After the word "and", strike the text "the Vice Chairman of "

Councilor Kim Gray arrived and was seated.

The motion was seconded and approved by the following vote: 8 Ayes – Jones, Robertson, Larson, Agelasto, Gray, Addison, Newbille and Hilbert; 0 Noes.

Mayor Levar Stoney provided remarks and an overview of the proposed education compact's three components:

- Quarterly meetings of Council and Richmond School Board
- Establishment of an "education compact" team
- Establishment of a "children's cabinet"

Councilor Agelasto stated that he would like a schedule of the quarterly meetings between the school board and Council confirmed and released to the public as soon as possible, an established deadline by which members are appointed to an advisory "education compact team", and a quarterly or biannual report submitted to the two bodies, of the impact of the children's cabinet discussions.

President Hilbert and School Board Chair Dawn Page requested that members be polled to schedule such quarterly meetings.
