General Assembly Legislative Update

Council Lobbyist Ron Jordan of Advantus Strategies, provided Council with an update regarding the city's legislative package items, as well as other bills that may impact the city, that were approved during the 2017 Virginia General Assembly (VGA) session, and are now awaiting action by the governor. Mr. Jordan also provided an overview of the VGA budget conference report, noting items that may be of interest to the city. A copy of the information has been filed.

Mr. Jordan asked Council to consider an earlier commencement of the city's 2018 VGA legislative process.

At 4:48 p.m., Councilor Kristen Larson moved that the City Council hold a closed meeting pursuant to Section 2.2-3711(A)(1) of the Virginia Freedom of Information Act for the purpose of discussing the performance of the city auditor, an appointee of the City Council.
