Richmond City Council met in the Council Chamber on Monday, April 10, 2017, at 6:07 p.m.

Invocation was offered by Reverend Chul Ki Kim, Emmaus United Methodist Church at Stratford Hills, 7740 Cherokee Road, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

AWARDS AND PRESENTATIONS

President Chris Hilbert, on behalf of City Council, and Mayor Levar M. Stoney, proclaimed the second full week of April as Richmond Public Safety Emergency 9-1-1 Telecommunicators Week and recognized the Department of Emergency Communications 9-1-1 Emergency Communications Center.

President Chris Hilbert and Councilor Ellen Robertson, on behalf of City Council, and Mayor Levar M. Stoney, proclaimed the last week of April 2017 as Richmond Affordable Housing Awareness Week and thanked those entities, organizations, and individuals working to help further and increase public awareness.

Councilor Ellen Robertson, on behalf of City Council, and Mayor Levar M. Stoney, proclaimed the month of April as Richmond Child Abuse Prevention Month to help further increase public awareness and protect children against the scourge of abuse.

President Chris Hilbert, on behalf of City Council, and Mayor Levar M. Stoney, recognized, honored and celebrated the Virginia Union University Lady Panthers Women's Basketball Team for an outstanding 2016-2017 season.

All members of Council and Mayor Levar M. Stoney recognized Mr. Fattah Muhammad for his many years of hard work and dedication to build better relationships between the residents and law enforcement officers of the Richmond community. Mr. Muhammad expressed his appreciation for the recognition.

CITIZEN COMMENT

John Moeser thanked Council for unanimously adopting legislation (Res. 2017-R15) to request a study of potential effects on the city of any proposed development in an area known as the Westwood Tract.

Glenwood Burley expressed concerns regarding the current conditions of the Richmond Police Department's horse barn and asked that Council support efforts for a new facility.

A copy of the information has been filed.

Leslie Buck, Friends of the Richmond Mounted Squad president, encouraged Council to consider an amendment to the fiscal year 2018 capital improvement program budget for the inclusion of funding for the construction of a new stable facility for the mounted horse squad.

Chris Lombardi expressed concern regarding (RPS) Richmond Public Schools' \$8.3 million unassigned fund balance and asked Council to introduce a budget amendment that would allow RPS to retain the funds.

Councilor Parker Agelasto clarified the city's policy regarding the RPS unassigned fund balance.

Councilor Kim Gray provided further clarification and stated that policy requires that a proposed budget amendment regarding the unexpended funds be assigned to a specific appropriation.

Ansley Perkins encouraged Council not to remove the \$8.3 million unassigned fund balance from Richmond Public Schools' budget.

Ann Wortham expressed concerns regarding the lack of a household debris disposal facility and illegal dumping in the East End area.

A copy of the information has been filed.

Vice President Cynthia Newbille stated that current budget deliberation sessions will provide an opportunity to address and resolve Ms. Wortham's concerns. Joseph Notarnicola, RPS Parent-Teacher Association representative, asked that Council develop policy that ensure that the \$8.3 million unassigned fund balance is returned and fully utilized by Richmond Public Schools.

MOTION

Councilor Kristen Larson moved that:

Council utilize funds in the amount of \$40,000 from the Fiscal Year 2016-2017 General Fund Budget, Council Agency line item – Management Services, for the procurement of an independent financial advisor to advise Council as needed regarding city business and finance.

Councilor Kim Gray explained that the proposed motion is not an uncommon practice.

Councilor Ellen Robertson expressed support for the proposed motion, stating that, at times, Council has needed advice on financial matters.

Deputy Council Chief of Staff Meghan Brown explained that the cited funds had been allocated to procure financial or economic development review advice regarding the Shockoe Bottom redevelopment proposal; however, the funds had not been expended since the withdrawal of the proposal.

Councilor Andreas Addison stated that the proposed motion would be beneficial to Council.

Deputy Council Chief of Staff Meghan Brown further explained that fiscal year 2017 third quarter projections predicted a shortfall in Council's personnel budget and limited funds are available

in Council's operating budget; however, funds could be allocated in fiscal year 2018 for the proposed motion, which would stipulate a request for proposal.

Councilor Ellen Robertson requested a comprehensive analysis of Council's current budget and asked that the scope of financial services expected from the proposed motion be defined.

City Attorney Allen Jackson reminded Council of limitations to the proposed motion regarding procurement practices and departmental budget guidelines.

Councilor Kristen Larson requested Council's support of an amendment to the fiscal year 2018 general fund budget for the proposed motion.

Vice President Cynthia Newbille suggested that the Finance and Economic Development Standing Committee review the proposed motion at its next scheduled meeting.

Councilor Kristen Larson withdrew her motion.
