

**PURPOSE:** To authorize the Chief Administrative Officer (CAO) to accept funds in the amount of \$10,000 from The Hartford and to appropriate the same to the Richmond Department of Fire and Emergency Services fiscal year 2018 Special Fund Budget for the purpose of supporting the Department's fifth grade Fire Life Safe-ty Program.

**REASON:** The Richmond Department of Fire and Emergency Services Seeks approval to use funds in the amount of \$10,000 awarded to the Department by The Hartford for its fifth grade Fire Life Safety Program.
