FY2019-2023 Revenue and Expenditure Plan

Jay Brown, Budget and Strategic Planning director, presented Council, as required by City Code, Section 12-15.1, with a five-year forecast of the city's estimated revenues and expenditures. Mr. Brown highlighted possible revenue increases in local taxes for real estate, lodging and prepared food, and underlined expenditure assumptions for certain personnel and operating costs. A copy of the presentation has been filed.

Councilor Parker Agelasto arrived at 3:25 p.m. and was seated.

President Hilbert asked that members of Council limit discussion and submit questions to the Council Chief of Staff office for a response.

Robert "Bob" Steidel, deputy chief administrative officer – Operations, was available to answer questions.

Mr. Brown stated that the 2nd quarter financial projections will be available on February 15th.

Councilwoman Reva Trammell arrived at 4:06 p.m. and was seated.

Richmond Redevelopment and Housing Authority Update

After discussion and comments regarding Council's willingness to working with the Richmond Redevelopment and Housing Authority to overcome recent facility maintenance issues within the public housing communities, along with the authority's unexpected leadership change, President Chris Hilbert stated that he will assemble a community meeting to continue discussions for developing comprehensive solutions surrounding public housing.

Closed Session Motion

At 4:26 p.m., Councilor Kristen Larson moved that the City Council go into a closed meeting pursuant to Section 2.2-3711(A)(19) of the Code of Virginia to discuss the results of the network vulnerability assessment audit because discussion of such information in an open meeting would jeopardize the security of the city's information technology systems.

The motion was seconded and unanimously approved.
