# ORDINANCE/RESOLUTION SUMMARY

The patron requests a resolution to express Council's opposition for extending the term of the existing agreement between the Economic Development Authority ("the Authority") and Pro-Football, Inc. ("the Company") who owns and operates the Washington Redskins.

## BACKGROUND

This resolution is to express City Council's opposition for extending the term of the existing agreement between the Authority and the Company who owns and operates the Washington Redskins.

The current term of the agreement is set to end on December 31, 2020; however, per the agreement the Company is to meet with the Authority no later than July 1, 2018, to determine the desire of both parties to extend the term of the agreement.

The patron believes the current contract is not in the best interest of the City of Richmond and Richmond City Council would not support renewal of the existing agreement. City Council could consider extending the agreement if the terms and conditions of the agreement are significantly amended to cover the costs of operating the facility as well as covering the debt service.
