Richmond City Council met in the Council Chamber on Monday, February 26, 2018, at 6:23 p.m.

Invocation was offered by Bishop Orrin K. Pullings, Sr., United Nations Church International, 214 Cowardin Avenue, Richmond, VA.

Members of Council and the audience recited the Pledge of Allegiance.

The motion was seconded and unanimously approved with the exception of the appointment recommendation of Kathryn M. Benedict, who was also approved: Ayes 8, Jones, Robertson, Larson, Gray, Trammell, Newbille, Hilbert. Noes, None.

Councilor Agelasto stated, during the vote, that he supported the recommendations to appoint Nathan Hughes to the Economic Development Authority, and Michael Todd to the Safe and Healthy Streets Commission.

AWARDS AND PRESENTATIONS

Councilwoman Reva Trammell, on behalf of Richmond City Council, and Mayor Levar Stoney, recognized Joseph A. "Joe" Mary, firefighter with the Richmond Department of Fire and Emergency Services, on his upcoming retirement after thirty years of public service to the city.

Councilwoman Reva Trammell, on behalf of Richmond City Council, and Mayor Levar Stoney, recognized members of Fighting More Than Fire, for the organization's donated time, talent, expertise and funding in assisting families rebuild their homes damaged or destroyed by fire or disaster.

Councilwoman Reva Trammell, on behalf of Richmond City Council, and Mayor Levar Stoney, recognized the RFD Foundation Metro Richmond Flying Squad, for its work providing health and comfort services to emergency first responders while on the scene of emergency incidents, and assisting residents displaced from their homes due to fires or other emergency events.

Annual Mayoral Report on Poverty Reduction and Community Wealth Building Initiatives

Mayor Levar Stoney presented the Office of Community Wealth Building (OCWB) 2018 Annual Report. Mayor Stoney recognized Director Reginald Gordon and staff of the OCWB on their dedication to the success of citizens. Mayor Stoney stated that the OCWB is creating a strong network with more than fifty Richmond organizations that address systemic barriers, create career plans and actively case manage 600 low income citizens. Mayor Stoney thanked Council for its support of the program.

Director Reginald Gordon spoke on the achievements of the office and stated that there is additional work to be done. Mr. Gordon thanked city administration, Council and members of the Citizen Advisory Board for their support.

Councilor Ellen Robertson, co-chair of the advisory board, thanked Mr. Gordon and staff, members of the advisory board and citizens for their hard work and support in moving the program toward success.

CITIZEN COMMENT

John Richmond addressed Council stating that the city needs additional bicycle lanes and requested that funding for the request be considered during budget deliberations.

Ann Worthom addressed Council stating that citizens are less important to the city if they are not a child or a student. Ms. Worthom questioned how dividing citizens into specific groups will unify Richmond.

William Shuman addressed Council expressing his support for a cost of living adjustment (COLA) for city retirees, as there has not been an increase since 2012.

Wayne Dawson addressed Council expressing his support for a COLA increase for city retirees, stating that he has not received such increase since 2007. Mr. Dawson requested that Council look for additional funding to provide a much needed raise to city retirees.

Lillie A. Estes addressed Council stating that the city tends to solve problems that do not exist and creates problems that do not need to be considered. Ms. Estes informed Council of the demands of the Coalition for Better Public Housing.

A copy of the information provided has been filed.

Larry Glidewell addressed Council expressing his support for a COLA increase for city retirees, as retirees have not received an increase since 2008; he stated that retirees were receiving increases each year that were similar to that of the Virginia Retirement System (VRS) before 2004. Mr. Glidewell also informed Council that, in 2017, the Richmond Retirement System (RRS) changed its policy to require that the funding status be 80% before a COLA is recommended to the RRS Board of Trustees, and such status would not be reached until approximately 2024.

Sha'Randa Taylor addressed Council expressing her concerns regarding the negligence of city leaders and the Richmond Redevelopment and Housing Authority (RRHA). Ms. Taylor informed Council of her living situation in RRHA housing, stating that, due to deplorable conditions, she developed several medical conditions.

Vice President Cynthia Newbille requested that RRHA Interim CEO Orlando Artze meet with Ms. Taylor to address her concerns.

Councilor Michael Jones moved to retain RES. 2017-R096 on the Regular Agenda for consideration, which was seconded.

Vice President Newbille stated that considering **RES. 2017-R096** on the Regular Agenda would allow administration to clarify any implications should the legislation be continued for 60 days.

Councilor Kim Gray stated that she had no objection to hearing from city administration regarding **RES. 2017-R096**; however, if continuing the resolution causes a budget implication, the resolution could be presented in the Mayor's budget with Council discussion during the budget process and the adoption of the budget occurring after April 23rd. Ms. Gray also stated that moving forward with the legislation and not reviewing all available options for consideration is a disservice to citizens.

Councilor Parker Agelasto stated that the current note on the Redskins facility is due in September 2018 and a 60-day continuance would allow Council the additional time to get control over a long term debt related to the facility. Mr. Agelasto also stated that the Redskins deal was rushed in 2012 and the solution for payment should not be rushed.

Councilor Andreas Addison stated that additional information needs to be provided prior to his decision on **RES. 2017-R096.** Mr. Addison also stated that he needs to understand the impact that a continuation of the legislation would have on the city.

Councilor Michael Jones reiterated the concerns of Councilor Addison regarding **RES. 017-R096**.

Councilor Kristen Larson stated that she supports discussion of **RES. 2017-R096**; however, the legislation should be continued after the discussion.

There were no further comments or discussions and the motion to retain **RES. 2017-R096** on the Regular Agenda was **approved**: Ayes 7, Jones, Robertson, Larson, Agelasto, Trammell, Addison, Newbille. Noes 2, Gray, Hilbert.

Councilor Ellen Robertson moved to amend the agenda as presented, excluding RES. 2017-R096, which was seconded and unanimously approved.

No. 2017-036, adopted May 15, 2017, which adopted the Fiscal Year 2017-2018 General Fund Budget and made appropriations pursuant thereto, by re-appropriating a \$2,000,000.00 portion of the Fiscal Year 2016-2017 fund balance excess, assigned by Resolution No. 2017-R078, adopted Nov. 6, 2017, to the General Fund Cash Transfer for Capital Projects program, and to appropriate these transferred funds to the Fiscal Year 2017-2018 Capital Budget by increasing estimated revenues by \$2,000,000.00, the amount appropriated to the Department of Public Works' Transportation Projects project in the Transportation category by \$1,250,000.00, and the amount appropriated to the Department of Public Works' Sidewalk Projects project in the Transportation category by \$750,000.00, all for the purpose of making improvements to roads and sidewalks in the city.

Opposition

Todd Woodson expressed opposition to **ORD. 2018-035** stating that the Monroe Park Conservancy should not be issued licensing due to the conservancy authorizing the removal of the tree canopy within the park. Mr. Woodson requested an audit of the Monroe Park Conservancy.

A copy of the information provided has been filed.

Earl Bradley expressed opposition to **ORD. 2017-196** and **ORD. 2018-029** stating that the city has not put procedures in place to assure that the community will receive the benefits of the Maggie Walker Community Land Trust or the Lead-Based Paint Hazard Control program. Mr. Bradley stated that there is no mechanism to address the oversight of these programs.

Briana Williams expressed concerns regarding **ORD. 2018-019** stating that she needs more clarity on the project and how it will affect the residents of the area.

John Richmond expressed opposition to **ORD. 2018-035** stating that he echoes the concerns of Todd Woodson and there is no representation from the Oregon Hill community on the Monroe Park Conservancy.

Support

Omar Al-Qadaffi expressed support of **RES. 2018-R012** stating that it is important to have well defined procedures in place for the review and adoption of the budget. Mr. Al-Qadaffi also expressed support for **ORD. 2018-036** stating that Oliver Singleton was a citizen who served on several of the city's boards and commissions and had great respect for the city of Richmond.

Nathan Beyah expressed support of **ORD. 2018-028** stating that he is appreciative of the city receiving a grant for lead removal; however, a comprehensive review needs to be done to ensure minority participation in all aspects of the lead abatement process.

Arthur Burton expressed support of **ORD. 2017-196** stating that he hopes The Maggie Walker Community Land Trust lives up to the Maggie Walker legacy and represents the opportunity to preserve and advance specific communities within the city.

Councilor Parker Agelasto stated that he appreciated the public comments regarding The Maggie Walker Community Land Trust and informed of a conflict of interest to **RES. 2018-R010**, since his employer holds the easement of Crooked Branch Ravine Park. Mr. Agelasto also stated that **ORD. 2018-019** allows for the installation of sidewalks and curbing within the specified area of the ordinance.

Deputy Chief Administrative Officer for Economic and Community Development Lee Downey stated that **ORD. 2018-019** allows for approximately sixteen feet of curb, gutter and sidewalk installation in the area of new construction, and the street will not be closed as the installation will be on the side of the street.

Councilor Ellen Robertson thanked the citizens who spoke in reference to **ORD. 017-196** and The Maggie Walker Community Land Trust. Ms. Robertson stated that the ordinance allows for an annual report to Council addressing specific goals and objectives for the upcoming year. Ms. Robertson also stated that the ordinance will allow for the necessary oversight of creating and redeveloping communities with critical needs.

There were no further comments or discussions and **the Consent Agenda was unanimously adopted with the exception of RES. 2018-R010, which was also adopted:** Ayes 8, Jones, Robertson, Larson, Gray, Trammell, Addison, Newbille, Hilbert. Noes None. Abstentions 1, Agelasto, due to a conflict of interest. A copy of the information has been filed.

To amend City Code § 11-104, concerning exceptions to the prohibitions on unlawful dumping and unlawful accumulation, to provide that bulk items and tree and shrubbery trimmings placed for collection by the City pursuant to City Code § 23-44 do not constitute unlawful accumulation, and to amend City Code §§ 23-1, 23-43, and 23-44, concerning the collection of solid waste, to require the Director of Public Works to provide for the regular collection of bulk items and tree and shrubbery trimmings.

Councilor Kim Gray stated that **ORD. 2018-027** seeks to offer clarity to the current bulk and brush program.

Support

Jerome Legions, Jr., president of the Carver Civic Association, expressed support of **ORD. 2018-027** stating that the proposed legislation will assist citizens with learning the proper procedure for discarding upholstered furniture.

Jonathan Marcus, president of the West Grace Street Association, expressed support of **ORD**. **2018-027** stating that citizens already pay additional fees for bulk pickup and the definition of bulk should include upholstered furniture and mattresses.

Kurt Engleman expressed support of **ORD. 2018-027** stating that adding upholstered items to the definition of bulk would be an asset to citizens and would automatically end some of the problems with bulk pickup.

Councilor Andreas Addison stated that improvements have been made in reference to bulk pickup; however, there appears to be a disconnect between what residents are directed to do and how the city responds. Mr. Addison also stated that citizens should have the ability to communicate with the city on bulk removal, and the city needs to ensure that there is enough staff and equipment available to complete the service.

Councilor Kristen Larson stated that **ORD. 2018-027** is following through on the bulk removal process that was approved in the Fiscal Year 2018 budget.

Councilor Parker Agelasto stated that he appreciates the work that the Department of Public Works (DPW) has done to improve the bulk program; however, the issue of cost continues to be a major factor for citizens. Mr. Agelasto also stated that he would be supporting **ORD. 2018-027** but requested that a report be provided to Council from city administration regarding the expectations and efficiency of the program.

Councilor Michael Jones stated that the city is treating the problem but is not finding a solution to the problem; furthermore, **ORD. 2018-027** does not offer the solution.

Councilor Ellen Robertson asked for clarity from city administration as to how citizens should request to have bulk trash removed.

Director of Public Works Bobby Vincent informed Council of the process to remove bulk and brush items and stated that DPW is working deligently to promote a clean and safe environment within communities. He also stated that mattresses cannot be placed outside the front of a home. Mr. Vincent also stated that trash from evictions are not included in the bulk and brush program but are handled through code enforcement efforts.

There were no further comments or discussions and **ORD. 2018-027 was adopted:** Ayes 5, Larson, Agelasto, Gray, Addison, Hilbert. Noes 4, Jones, Robertson, Trammell, Newbille.

The following resolution was considered:

RES. 2017-R096

To authorize the issuance of general obligation public improvement refunding bonds of the City of Richmond, Virginia in the maximum principal amount of up to \$8,600,000 to refund all or portions of certain general obligation bonds previously issued by the City; to authorize the Director of Finance, with the approval of the Chief Administrative Officer, for and on behalf of the City, to sell such refunding bonds for such purposes; to provide for the form, details and payment of such bonds; and

to authorize the issuance of taxable bonds in the same maximum principal amount and payable over the same period as such general obligation public improvement refunding bonds.

Deputy Chief Administration Officer (DCAO) for Finance Lenora Reid provided a brief overview of **RES. 2017-R096** stating that, in 2012, the referenced debt was placed on the city and the city put itself on an interest only loan of which the next payment is due September 1, 2018. Ms. Reid requested that Council adopt **RES. 2017-R096** to allow the city to pay the debt. Ms. Reid also stated that, if **RES. 2017-R096** is continued, the city must place \$8.6 million in the proposed FY19 Operating Budget but the city does not have \$8.6 million in operating funds.

Opposition

Arthur Burton spoke in opposition to **RES. 2017-R096** stating that the city can quickly find millions for the richest that come into the city but cannot provide funding to assist the everyday citizen or the less fortunate.

Nathan Beyah spoke in opposition to **RES. 2017-R096** stating that Council should take its time in making a decision on the fiduciary responsibility of the loan.

Omar Al-Qadaffi spoke in opposition to **RES. 2017-R096** stating that Council should consider additional options before making a decision on the loan.

Councilor Andreas Addison expressed concerns regarding paying a short-term interest payment on an interest only loan and questioned whether there will be assurance that the payment will not affect the capital improvement plan (CIP) budget. Mr. Addison also stated that he is not aware of the loan terms and requested information on the difference between the interest only loan and a twenty year bonded general obligation funded project.

Councilwoman Reva Trammell stated that Council should delay its decision on the proposed legislation.

DCAO Lenora Reid stated that, if **RES. 2017-R096** is not adopted, \$8.6 million will be placed in the proposed budget for consideration, but if the legislation is adopted, \$750,000 will be used to make the next debt service payment.

Councilor Kristen Larson stated that **RES. 2017-R096** allows Council an opportunity to explore additional options for repayment of the loan, and if there is an option that will not affect taxpayers, Council should consider it.

Councilor Michael Jones confirmed that the \$750,000 payment is for one year and the remaining balance would be paid over a period of fifteen years. Mr. Jones asked if a decision is not made on the legislation and the \$8.6 million is placed in the Mayor's proposed budget, can Council make changes for future payments.

DCAO Lenora Reid stated that Council could put forth an ordinance to issue a debt for the facility at any time; however, Council would need to continue reviewing payment options.

Councilor Parker Agelasto provided a brief history of the process that Council took to make the Redskins project a reality and addressed his concerns related to the agreement between the city and the Redskins, and to changes made within the agreement by the city's Economic Development Authority (EDA). Mr. Agelasto stated that the EDA has control of the building, the city does not, and Council cannot obligate the EDA to do anything under the legal premise of the agreement. Mr. Agelasto also stated that administration should ask the EDA to sign the property over to the city.

Councilor Kim Gray stated that there are a lot of moving parts to the agreement, and since a financial advisor has been retained, Council should consult with the advisor as to how to relieve the city of the debt. Ms. Gray also stated that Council should consider continuing **RES. 2017-R096** for at least thirty days to evaluate the entire agreement before making a decision.

Vice President Cynthia Newbille stated that she agrees with the need to reconsider the options regarding the Redskins deal; however, after July 1, 2018, the city will have the opportunity to draft new terms in the memorandum of agreement (MOA). Ms. Newbille also stated that continuing **RES. 2017-R096** for sixty days is not needed if the city is not able to renegotiate the terms of the agreement without the EDA, the Redskins and the city.

City Attorney Allen Jackson stated that July 1, 2018, relates to a renewal of the agreement through the agreement's expiration of December 31, 2020, and does not mean a renegotiation of terms during the balance of the agreement.

President Chris Hilbert read an excerpt from the City Charter stating that, if the \$8.6 million is placed within the budget, Council cannot transfer the funds outside the specified area of appropriation.

Councilor Larson asked if **RES. 2017-R096** were to be approved after a continuation of thirty days, would the legislation override the \$8.6 million in the budget proposal.

City Attorney Allen Jackson referenced § 6.10 of the City Charter regarding the debt service and stated that the charter does not state that Council can adopt legislation that will supplant the \$750,000 payment for the \$8.6 million payment.

Councilor Robertson requested clarification on the statement from the City Charter.

City Attorney Jackson stated that the City Charter states that "no item of expenditure for debt service shall be reduced or stricken out" per § 6.10 of the City Charter.

Councilor Jones requested to be added as a co-patron to legislation to be introduced later that evening regarding opposition to extending the terms of the Washington Redskins agreement with the city.

Councilor Gray inquired as to why the proposed legislation wasn't put forth sooner.

Councilor Addison stated that the city has the debt and has been paying the interest on it over the past five years, but now is the time to pay the actual debt. Mr. Addison also stated that **RES. 2017-R096** was introduced on December 11, 2017, and was reviewed by the Finance and Economic Development Standing Committee in January and February of 2018.

Councilor Agelasto stated that no one wants the city to default on the debt and a determination of how to minimize the financial impact on the city is necessary. Mr. Agelasto requested the EDA's current fund balance.

President Hilbert stated that the remaining \$7.85 million of the \$8.6 million can be allocated to additional items in the Mayor's budget proposal by passing **RES. 2017-R096**, and he is willing to write a letter on behalf of Council requesting that the administration provide a report of the EDA by a specified date.

There were no further comments or discussions and **RES. 2017-R096 was adopted:** Ayes 6, Jones, Robertson, Larson, Addison, Newbille, Hilbert. Noes 3, Agelasto, Gray, Trammell.
