Richmond City Council met in the Council Chamber on Monday, March 26, 2018, at 6:05 p.m.

Mr. Harmon accepted the recognition and expressed thanks to City Council for the award.

CITIZEN COMMENT

Joe Nelson addressed Council regarding the benefits and potential tax revenue for short-term home rentals. Mr. Nelson indicated that the fees associated with short-term rental permits and the application process discourage citizens from applying.

A copy of the information provided has been filed.

Councilor Kim Gray advised Mr. Nelson that she anticipated legislation will be introduced within the near future to address Airbnb and other short-term rentals in the city.

Jeanie Rule, board member of the Carytown Merchant Association, addressed Council regarding the importance for Council to continue its financial support of Carytown and asked that consideration be given to increasing the current funding amount.

Support

Penn Burke, grandson of slain Richmond Police Officer J. Harvey Burke, expressed support of **RES. 2018-R022** and recalled the support the Richmond Police Department provided to his family following the death of his grandfather in the line of duty. Mr. Burke stated that he and his late father were heavily involved in the police memorial statue and he urged Council for its support.

Richmond Police Chief Alfred Durham expressed support of **RES. 2018-R022** and provided a historical overview of the number of Richmond police officers slain in the line of duty. Chief Durham remarked that renaming Trafford Road would be a means to honor those slain officers and their families.

Glenwood Burley, chair of the Police Memorial Research and Relocation Site

Committee, expressed support of **RES. 2018-R022** stating that a unanimous vote on the proposed legislation would be a symbol of Council's appreciation for law enforcement officers, living or deceased, throughout the region.
