Richmond City Council met in the Council Chamber on Monday, April 9, 2018, at 6:00 p.m.

AWARDS AND PRESENTATIONS

Mayor Levar Stoney and Richmond City Council proclaimed the second full week of April as Richmond Public Safety Emergency 9-1-1 Telecommunicators Week and thanked the city's telecommunicator professionals for their endeavors in helping to make the city a safer and healthier place to live, work, learn, play, visit and raise a family.

Councilor Kristen Larson, on behalf of Richmond City Council, and Mayor Levar Stoney proclaimed the second week of April as Richmond Public Library Week, and thanked the dedicated librarians, staff and volunteers, supporting boards and associations for helping to make Richmond a better, smarter and more empowered place to live, work, learn, play, visit and raise a family.

CITIZEN COMMENT

Marilyn Olds, Richmond Tenants Organization (RTO) president, addressed Council informing the body that the RTO is the voice for the public housing communities. Ms. Olds also stated that the Richmond Redevelopment and Housing Authority (RRHA) and RTO have been in partnership for over twenty years and concerns are addressed at monthly meetings.

Councilwoman Reva Trammell expressed appreciation to Ms. Olds for her work in the communities and for keeping her abreast of events within the communities.

Patricia Williford identified herself as the Mosby Court Tenant Council president and RTO treasurer.

Patrice Shelton identified herself as the Hillside Court Tenant Council president and invited Council to visit the Hillside Court community.

Dyanne Marie Broidy identified herself as the Fairfield Tenant Council vice president.

Audrey Tack identified herself as the Frederic A. Fay Towers Senior Residence Tenant Council president and invited Council members to visit Fay Towers.

Debbie Wilkes identified herself as the 1611 4th Avenue Tenant Council president.

Cynthia Vaughan identified herself as the Old Brook Circle Senior Community president.

Annie Mahdee identified herself as the Gilpin Court Tenant Council president.

Vice President Cynthia Newbille voiced her appreciation to each speaker and leader of the public housing communities for their years of dedicated service to the youth and families that reside in these communities.

CONSENT AGENDA

ORD. 2018-022

To amend Ord. No. 2002-17-48, adopted Feb. 11, 2002, which authorized the special use of the properties known as 8 and 10 East Main Street for conversion and use of the ground floor levels of the existing buildings for dwelling purposes, together with off-street parking, to also permit such properties to be used for short-term rental, upon certain terms and conditions. (As Amended)

ORD. 2018-023

To authorize the special use of the property known as 806 Cathedral Place for the purpose of permitting up to five rooms or groups of rooms for short-term rental, upon certain terms and conditions. (As Amended)

ORD. 2018-100

To amend and reordain City Code § 9-58, which assigns polling places in the city, to relocate and establish a new polling place for Precinct 413.

RES. 2018-R028

To approve an expenditure in the amount of \$500.00 from the Council District Funds for the Seventh District to pay Ladies Who Lead, LLC, for the digital dissemination of Seventh District announcements and information through certain social media outlets from December 31, 2017, through March 1, 2018.

Opposition

Jack Pearsall spoke in opposition to **ORD. 2018-022** and **ORD. 2018-023** stating that the properties are not going to be used for short-term rentals but as commercial hotels. Mr. Pearsall also stated

that he understands that the city is working to determine regulations regarding short-term rentals and requested that Council defer action on these ordinances until after the regulations are adopted.

Cyane Crump, Historic Richmond Executive Director, requested that Council delay action on **ORD. 2018-022** and **ORD. 2018-023** until after regulations have been adopted that will address the use of Airbnb.

Omar Al-Qadaffi spoke in opposition to ORD. 2018-022 and ORD. 2018-023 stating that the city needs to focus on affordable low-income housing as opposed to facilitating additional Airbnb's.

Jacob Canova spoke in opposition of **ORD. 2018-023** stating that the project has become larger than originally noted and he foresees disruption in the community with a hotel that no one is managing. Mr. Canova also noted that the property is the only remaining single family dwelling that faces Monroe Park.

Support

David Johannas, architect for the projects, spoke in support of **ORD. 2018-022** and **ORD. 2018-023** regarding short-term rental properties. Mr. Johannas stated that he has had previous conversations with Mr. Canova and Mr. Canova has expressed support for the 806 Cathedral Place project. Mr. Johannas informed Council that there have been discussions with neighbors, civic associations, the Commission of Architectural Review and the planning staff, with support from all groups. Mr. Johannas noted that the applications for these properties are not for an Airbnb use but for short-term rentals which require constant staffing.

Councilor Parker Agelasto expressed concerns regarding the approval of special use permits (SUP) for short-term rentals, when it has been noted that the city is working to address regulations for short-term rentals within the city.

Councilwoman Reva Trammell stated that there appears to have been miscommunication between the developers of these projects and members of the communities.

Councilwoman Trammell **moved** to **continue ORD. 2018-022** and **ORD. 2018-023** to the April 23rd Council meeting, which was **seconded**.

Councilor Andreas Addison expressed his support for **ORD. 2018-022** and **ORD. 2018-023** noting that concerns raised by community members could be addressed by the city registering with Airbnb and having a standardized process for anyone considering a tourism approach to housing.

Councilor Kristen Larson acknowledged that the city does need to address Airbnb regulations and requested feedback from the members whose districts encompass the properties.

Councilor Ellen Robertson stated that one of the properties is located within the 6th Council District and there has not been any negative communication expressed to her until she received an email on Friday, April 6th, regarding concerns. Ms. Robertson informed Council members that she supports **ORD. 2018-022**.

Councilor Kim Gray stated that she is in support of **ORD. 2018-023**; however, her primary concern is the need for a local contact to address any issues and the impact that it will have on the immediate neighbor of the property.

Vice President Cynthia Newbille noted that safeguards are provided within **ORD. 2018-022** and **ORD. 2018-023** and that she will be supporting the proposed legislation.

Council considered Councilwoman Trammell's **motion** to **continue ORD. 2018-022** and **ORD. 2018-023** to the April 23rd Council meeting. The motion **failed**: Ayes 3, Agelasto, Trammell, Hilbert. Noes 6, Jones, Robertson, Larson, Gray, Addison, Newbille.

Councilor Larson stated that **ORD. 2018-100** aims to ensure that the revenue generated from the new meals tax is reported to Council on a monthly basis.

Ms. Larson announced that **ORD. 2018-112** will change the voting location for citizens of Voting Precinct 413, from Southampton Baptist Church on Cherokee Road, to St. Luke Evangelical Lutheran Church on Chippenham Parkway. Ms. Larson informed that citizens affected by this change will be contacted by the Office of the General Registrar.

There were no further comments or discussions and the Consent Agenda was unanimously adopted with the exception of ORDS. 2018-022 and 2018-023, which were also adopted: Ayes 7, Jones, Robertson, Larson, Gray, Trammell, Addison, Newbille. Noes 2, Agelasto, Hilbert.
