Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do bereby officially proclaim:

Richmond Safe Boating Week

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to celebrate the warm weather months and the many opportunities for safely enjoying the bounty of nature's abundant rivers, lakes and oceans; and

Whereas, Boating for recreation, sport and relaxation is a favorite pastime of many Richmond Residents who look forward to getting out on the water with their families and friends; and

Whereas, Each year the number of water activities and enthusiasts grows, as does the amount and types of motorized and self-propelled watercrafts that are available and being used on the water; and

Whereas, A substantial number of boats registered in Virginia are owned and operated by those living in Richmond and the Greater Richmond Metro Area; and

Whereas, Boating safety is a critical and ever-present individual and shared responsibility that includes the active concern, action, and protection of each person; their family and friends; and, all those around them; and

Whereas, In 1952, the United States of America Coast Guard Auxiliary began observing a Safe Boating Week as part of their events held in Massachusetts and continued the tradition until 1957, when they created a National Safe Boating Week across the country; and

Whereas, In 1958, the Congress of the United States of America requested, by Joint Resolution, and President Dwight D. Eisenhower proclaimed a week in July as National Safe Boating Week, which in 1995 was shifted to the month of May to coincide with Memorial Day; and

Whereas, The United States of America Coast Guard Auxiliary Flotilla 31, Richmond, Virginia, Division 3, 5th Coast Guard District, Southern Region, is an all volunteer civilian organization that dutifully and faithfully serves the Richmond area in providing boating safety education classes and complimentary vessel safety checks throughout the year; and

Whereas, In 2013, Richmond City Council officially proclaimed and established the seven days in May prior to Memorial Day Weekend to be Richmond Safe Boating Week;

Now, Therefore, In recognition of safe boating practices, education, and responsible watercraft usage, Richmond City Council does hereby re-proclaim the seven days in May prior to Memorial Day Weekend each year to be Richmond Safe Boating Week in Richmond, Virginia; and, urges all Richmond boaters to take boating safety courses; wear life jackets; have their boats checked for maintenance and safety equipment; and, practice safe boating.

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to recognize, honor, and celebrate bicycling as an efficient, economical, and environmentally-friendly form of transportation; and, a fun recreational sport for residents of all ages; and

Whereas, Bicycling is considered to have important impact on helping reduce pollution, and bicycle-friendly communities are known to have residents of increased health, well-being, and quality of life; and

Whereas, Richmond has long been distinguished by its well-established bicycling culture that dates back to the late 1800s and the early use of modern-style bicycles in the United States of America; and

Whereas, As a direct demonstration of its support of and commitment to bicycling, Richmond established a coordinated effort within the Richmond Department of Public Works, Division of Transportation Engineering, that focuses on overseeing, leading, and impacting projects, policies, and funding related to pedestrians, bicycling, and trails in the city; and

Whereas, Some additional celebrated examples of Richmond's commitment to bicycling include it being acclaimed for providing municipal bike racks and being one of the first cities in North America to install bike carriers on its public busses; and

Whereas, In 2015, Richmond City Council proclaimed and established the month of May of each year to be Richmond Bicycling Month and the third week of May to be Richmond Bicycle To Work Week; and

Whereas, In helping to further develop, shape, and plan bicycle-friendly infrastructure and amenities, Richmond has also produced an active Richmond Bicycle Master Plan that provides a framework for current and future bicycling-focused efforts; and

Whereas, Additional work in recent years includes the completion of 28 miles of marked bike lanes and more than 60 sharrows, and the establishment of plans for more in the future; creation of the Cannon Creek Bike/Walk Greenway; construction of the nationally acclaimed T. Tyler Potterfield Memorial Bridge walk and bike shared use pathway over the James River; installation of a protected bicycle lane on Fairfield Way; and, making enhancements to the James River Park System Trails; and

Whereas, In August 2017, Richmond launched RVA Bike Share, a municipal bicycle rental system that currently includes 16 stations and 170 bicycles, with plans for further expansion; and

Whereas, Richmond City Council is a strong supporter, champion, and advocate on behalf of policies, practices, and funding that supports the increased health, well-being, quality of life, and success of all Richmond residents;

Whereas, Some of the many important people supporting the delivery of Emergency Medical Services include: Administrative Staff, Paramedics, Emergency Medical Technicians, Firefighters, Public Information Officers, Emergency Nurses and Physicians, Maintenance Technicians, Medical Instructors/Educators, and Emergency Communications Operators; and

Whereas, In 1974, The Honorable Gerald R. By virtue of the authority vested in the United States of America, Commonwealth of Virginia, Virginia Code of Laws and the Richmond City Charter: The Honorable Levar M. Stoney, Mayor of Richmond and The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby and officially proclaim:

The Honorable Oliver W. Hill, Sr. Day

Whereas, The Honorable Levar M. Stoney, Mayor of Richmond, and The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to recognize, honor and celebrate the promise encompassed in the ideal, exercise and governance of the "rule of law" legal principal; and

Whereas, Articles I, II and III of the Constitution of the United States of America define the three branches of our government as Executive, Legislative, and Judicial, which has influenced the social landscape of our great nation and served as the truest framework for freedom; and

Whereas, In order to officially acknowledge and venerate the importance of the "rule of law" as a fundamental American tenet, in 1958 The Honorable Dwight D. Eisenhower, President of the United States of America, established Law Day as a national day of observance regarding the importance of the rule of law; and, in 1961, the U.S. Congress designated May 1 of each year as Law Day; and

Whereas, In commemoration, each year the American Bar Association and many local chapters and judicial entities across the nation hold events around May 1; and

Whereas, In 1997, the Supreme Court of Virginia - Richmond Juvenile and Domestic Relations Court began holding an annual "Oliver Hill Day" in conjunction with Law Day to honor the life, service and legacy of The Honorable Oliver W. Hill, Sr.; and

Whereas, Born in Richmond, Virginia, Mr. Oliver W. Hill, Sr. (May 1, 1907-Aug. 5, 2007) served our community, state and country as a civil rights attorney, humanitarian and leader; and

Whereas, From 1948 to 1950, Mr. Hill held the distinction of being one of the first nine individuals to be elected as a Member of Richmond City Council (and the first person of African American descent) under the city's then Council-Manager form of government; and

Whereas, As a litigator, Mr. Hill served critical roles at state, local and national levels representing African Americans and helping win landmark civil rights rulings; he also served as a member of the United States Army during World War II; and, among innumerable other tributes, was bestowed the Unites States of America Presidential Medal of Freedom, our nation's highest civilian award, by The Honorable William J. Clinton, President of the United States of America, in 1999;

Now, Therefore, In recognition, honor and celebration of the promise and principles encompassed in the ideal, exercise and governance of the "rule of law" and the outstanding life and legacy of The Honorable Oliver W. Hill, Sr., Richmond City Council and Mayor Levar M. Stoney do hereby officially proclaim May 4, 2018 as The Honorable Oliver W. Hill, Sr. Day and bring this to the attention of all Richmond residents.
