THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 8-277 of the Code of the City of Richmond (2015), as amended, be and is hereby **amended** and reordained as follows:

**Sec. 8-277. Fee for use of Dogwood Dell Amphitheater [~~and Carillon~~] in Byrd Park.**

~~(a)~~ *Dogwood Dell Amphitheater.* A fee as set forth in Appendix A to this Code shall be charged and paid into the City treasury for the use of the Dogwood Dell Amphitheater in Byrd Park for programs other than Festival of Arts productions staged under the joint auspices of the Department of Parks, Recreation and Community Facilities. The programs for which the fee is to be imposed include graduation ceremonies, orientations, and sponsored performances and

productions, other than the Festival of Arts. The person to whom the Dogwood Dell Amphitheater is rented shall not charge admission for any such performance or activity. This fee does not allow for access to the equipment tunnel or dressing rooms. The fee per day for complete access is as set forth in Appendix A to the Code.

~~[(b) — Carillon. Fees as set forth in Appendix A to the Code for the use of the Carillon in Byrd Park shall be charged and paid into the City treasury.]~~

§ 2. That the fees set forth in Appendix A of the Code of the City of Richmond (2015) for section 8-277 of the Code of the City of Richmond (2015) be and are hereby **amended** and reordained as follows:
