I like the addition of temporary, performing and media arts to the definition of public art. I also like the phased timing of the recommendations.

Some more specific comments to consider:

How do the latest political discussions about Monument Ave and other confederate monuments impact the recommendations or how they are delivered?

Dept of Cultural Affairs- there's probably more in the detail about this but would like to explore this further with you. I do think a City position at a "cabinet" level would be helpful, and it's something the arts and culture leaders suggested to the Mayor back in December.

Top of page 10 references Essential Resource but no description. Interested to read that in the final version.

P.14 references arts vibrancy index from NCAR and how we fell out of the top 20 last year. I believe that's the SMU study that earlier this year has us back in the Top 20. May want to reference that.
