## CHAMBER EMERGENCY EVACUATION PLAN AND CITIZEN SPEAKER GUIDELINES

# **AWARDS AND PRESENTATIONS**

President Chris Hilbert, on behalf of Richmond City Council, recognized Dr. Gary L. Rhodes, President of J. Sargeant Reynolds Community College, on his upcoming retirement after nearly 40 years in higher education.

#### **CITIZEN COMMENT**

**Melvin Jones** informed Council of the Maggie Walker celebration that will be held on Saturday, July 14<sup>th</sup>, and requested that Council generate a proclamation in honor of the first anniversary of the Maggie Walker statue. Mr. Jones expressed concern relating to a shooting that

took place on Memorial Day and stated that the responding police officer was more concerned with the care of the individual that was injured as opposed to his own safety. Mr. Jones requested that citizens support the city's police officers and that Council work deligently to improve the safety of neighborhoods.

Councilwoman Reva Trammell stated that she appreciated Mr. Jones' expression of thanks and support to the police officers and Police Chief Alfred Durham, and Richmond citizens need to support all safety personnel.

**Elder Nathaniel M. Bassett, III** expressed concern relating to neighborhood blight and crime in the area of his residence, and questioned city repair needs that are not being completed even with the increase of city taxes.

Councilwoman Trammell thanked Mr. Bassett for expressing his concerns to Council and referred him to a 2<sup>nd</sup> precinct police officer that was in attendance at the meeting.

Ms. Cuffee-Glenn stated that city administration has been working with the RPS superintendent and school board, and the deadline for having two new elementary schools completed is 2020.

Vice President Cynthia Newbille confirmed that a joint construction team is in place with representatives from RPS and city administration that will be addressing concerns regarding the construction of new schools.

Councilor Kristen Larson stated that Council should move forward with the proposed legislation as a result of lessons learned from previous school construction issues, and the proposed resolution offers transparency through the entire construction process.
