Councilor Parker Agelasto, on behalf of Richmond City Council, recognized the Richmond Department of Public Works, Division of Transportation Engineering for its work on behalf of pedestrians, bicycles and trails.

Councilor Kristen Larson and Councilwoman Reva Trammell recognized the Richmond Emergency Medical Services professionals and staff and re-proclaimed the third full week of May as Richmond Emergency Medical Services Week.

CITIZEN COMMENT

Chuck Richardson requested that Council consider a change to Council's Rules of Procedure that requires the mayor to be in attendance at Council meetings.

Charles Johnson expressed appreciation for the improvements made in the Blackwell Community and requested that there be additional policing of specific areas within the community.

Carl Otto provided Council with a brief history of the Rockets community and requested that Council support the Economic Development Authority's project to redevelop the Fulton area of the city.

Ashley Kistler, vice chair of the Public Art Commission (PAC), provided information regarding the PAC's new master plan and requested that Council ensures that the master plan move through administrative review without further delay. REGULAR AGENDA

The following resolution was considered:

RES. 2017-R092

To establish a policy of the Council that the Council will appoint a current City retiree to the Board of Trustees of the Richmond Retirement System to fill one of the three appointments not required to be a member of the classified service.

Support

William Shuman spoke in support of the proposed legislation stating that city retirees made the request for a retiree to be appointed to the Board of Trustees of the Richmond Retirement System so the voice of retirees would be heard.

There were no further comments or discussions and **RES. 2017-R092 was unanimously** adopted.

The following resolution was considered:

RES. 2018-R034

To declare a public necessity to amend the zoning ordinance and to initiate an amendment to the City's zoning ordinance to rezone certain properties located in the West Cary Street area, generally bounded by West Main Street to the north, Cumberland Street to the south, South Belvidere Street to the east, and South Cherry Street to the west, from the B-3 General Business District to the UB-2 Urban Business District and the B-6 Mixed-Use Business District.

Councilor Parker Agelasto provided detailed information related to RES. 2018-R034.

Opposition

Jennifer Mullen, property owner legal representative, expressed opposition to the proposed legislation, stating that it will slow down area development, cause an adverse financial impact and require additional parking areas.

Larry Cluff expressed opposition to the proposed resolution stating that spot rezoning is not morally, ethically and legally proper, and the developer received a zoning confirmation letter prior to purchasing the property.

Preston Lloyd, attorney representing six property owners, requested that Council take time to reconsider the rezoning approach that has been proposed within the paper as it relates to future incentives for redevelopment within the area.

Lory Markham, representing the developer, expressed opposition to the proposed resolution as there would be no difference in the height or density of the development, regardless of the zoning for the proposed area.

Support

William McCormick, Oregon Hill Neighborhood Association vice president, read a statement from president Todd Woodson stating that the association has been working to change the zoning of the West Cary Street corridor for several years, and Director of Planning and Development Review Mark Olinger had expressed that the UB-2 Urban Business District zoning was appropriate and the zoning should be changed.

Charles Pool requested that Council support the proposed resolution which would allow the Oregon Hill Neighborhood Association to appeal the zoning ruling of the zoning administrator.

Scott Burger, member of the Oregon Hill Neighborhood Association, expressed support of the proposed resolution, stating that the adoption of the legislation would affect specific areas of the entire city and would show Council's support of the request of citizens.

Barbara A. Carter requested that Council adopt the proposed resolution to allow for the proper rezoning of the area to a UB-2 Urban Business District.

Caroline Cox requested that Council adopt the proposed resolution so the West Cary Street corridor would be in line with the city's Master Plan.

Lynn Ivey, president of the Overlook Unit Owners Association, stated that the organization is in full support of the Oregon Hill Neighborhood Association's position, and requested that Council adopt the proposed resolution.

Claire Schutt, an Oregon Hill resident, stated that she supports the rezoning as noted in the proposed resolution and requested that citizens in attendance stand to show their support.

Omar AI-Qadaffi stated that he was inspired by the residents who came in support of the proposed resolution and their efforts to preserve the designated area.

Councilor Kim Gray stated that she is sympathetic to the concerns of the area citizens and stated that a review for proper zoning and an examination of the land use and policies of the area is warranted.

Councilor Kristen Larson stated that she has concern that the rezoning of one building would inspire the rezoning of an entire area.

Councilor Parker Agelasto stated that he introduced legislation in 2013 to study the B-3 General Business District zoning throughout the city as the B-3 zoning was considered an inappropriate category. Mr. Agelasto also stated that the study came to Council in 2015 and Council has not acted on many of the requests. Mr. Agelasto further stated that the request within the proposed resolution is not inappropriate when other areas with major anterior roads have been rezoned, and the area referenced is trying to not have inappropriate development.

President Chris Hilbert stated that he appreciates what the neighborhood is trying to do; however, he cannot support the proposed resolution.

There were no further comments or discussions and **RES. 2018-R034 was rejected:** Ayes 3, Jones, Agelasto, Trammell. Noes 6, Robertson, Larson, Gray, Addison, Newbille, Hilbert.

President Chris Hilbert requested suspension of Council's Rules of Procedures to allow a public hearing on **ORD. 2018-110**, which was continued to the May 29, 2018 Council meeting.

Opposition

Bernice Travers expressed opposition to the proposed legislation stating that qualified applicants can be found within the city to fill vacant positions and employing individuals from outside the city would cause low morale among current employees.

Claire Schutt expressed opposition to the proposed ordinance stating that employees who do not live in Richmond do not experience the issues of the city; furthermore, they receive the financial backing of the city's taxpayers and pay their taxes to neighboring counties.

Omar Al-Qadaffi stated that he finds the proposed legislation offensive and that the inability to find qualified employees within the city is a failure of the city's Human Resource Department.

Sid Simmons expressed opposition to the proposed ordinance stating that an employee who lives outside of the city could have a conflict of interest when making decisions for the city.

Emma Clark stated that she is opposed to the proposed legislation, stating that an employee that lives outside of the city would not experience the outcome of their decisions.

Marty Jewell stated that there is an enhanced pool of qualified applicants within the city since its population has grown.

Chuck Richardson expressed his concern regarding the proposed ordinance stating that, if individuals are not required to live within the city, Richmond will be supporting neighboring localities.

President Hilbert announced that Council was returning to the agenda as presented.

Public Hearing Speakers

Emma Clark spoke in opposition to **ORD. 2018-060** stating that the Mayor and Council have not provided enough funding within the proposed budget to sustain the Richmond Public Schools' (RPS) budgetary needs.

Betsy Milburn spoke in opposition to **ORD. 2018-060** stating that the lack of funding for RPS results in the school division not having enough personnel to complete student transcripts accurately nor does it allow for enough school bus drivers to meet the needs of students.

Glenwood Burley, Richmond Regional Mounted Police and Barn Project chairman, expressed support of **ORD. 2018-059** and thanked Council for placing funding in the budget to begin the process of receiving a regional horse stable for the capitol, local and Virginia Commonwealth University (VCU) police departments.

Keith Andes, Richmond Professional Firefighters Association president, expressed support of **ORD**. **2018-071** and shared his appreciation to Council for the 1% pay increase for city employees; he stated that he hopes Council will continue to fund increases for employees.

David Henderson requested clarification relating to the new positions referenced in **ORD. 2018-080** and expressed his opposition to the proposed ordinance commenting that, if an employee works within the city, the employee should also live within the city.

City Attorney Allen Jackson explained **ORD. 2018-080** stating that the proposed ordinance adds two newly created positions to the residency requirement which would take effect July 1, 2018.

ORD. 2018-061

To adopt the Debt Service Fund Budget for the fiscal year commencing Jul. 1, 2018, and ending Jun. 30, 2019, and to appropriate the estimated expenditures from the Debt Service Fund for the said fiscal year.

Councilor Kim Gray explained that Richmond Public Schools (RPS) cannot accumulate balances, and if there is a \$12.5 million surplus, it is due to the lack of financial management within RPS.

Councilwoman Reva Trammell reported that she went on a tour of the old Oak Grove Elementary School at 2200 Ingram Avenue where she saw unused textbooks and requested that she be allowed to take the textbooks to other locations, such as libraries, where they could be used by citizens. Ms. Trammell suggested that the School Board do a better job of removing items when a school location has closed.

Councilor Kristen Larson thanked Council staff for their work to streamline the budget process stating it was more efficient; however, she expressed disappointment in the handling of funding for the Public Art Commission (PAC) and explained that Council should work to restore PAC funds over the next twelve months. Ms. Larson also expressed concern regarding adherence to the adopted budget format, and stated that Council needs to work harder to fund the Capital Improvement Projects (CIP) budget.

Councilor Parker Agelasto agreed that there was improvement in the budget process; however, continued improvement to the process is needed. Mr. Agelasto expressed his disappointment in the budget's public infrastructure and public education funding.

Councilor Ellen Robertson stated that a major accomplishment for Council was approving the needed funding for the police and fire departments prior to the budget process, which eliminated much discussion during the budget work sessions. Ms. Robertson also stated that she is hopeful an agreement can be made between administration and the schools as to the needs and resources for school funding, prior to next year's budget season. Ms. Robertson explained that the budget emphasizes funding for youth through programs with parks and recreation, and the continued work to reduce city poverty and to fund affordable housing within the city are major components of the budget. Ms. Robertson further stated that extending library services and additional resources are funded within the budget and thanked President Hilbert and Vice President Newbille for effectively presiding over Council's budget deliberations.

Councilor Michael Jones stated that Council has to find a better way to fund schools and the proposed budget is strong in funding additional budget areas. Mr. Jones asserted that Council is committed to making sure that RPS has what it needs and tough decisions will be made in the future to ensure funding.

Councilor Andreas Addison remarked that there are still challenges facing the city but there are also many accomplishments. Mr. Addison stated that Council placed an emphasis on school funding; however, the city needs to improve its process to generate additional revenue to fund the schools.

Vice President Cynthia Newbille thanked Council staff for the improvements in the budget process. Ms. Newbille also explained that Council still has challenges ahead regarding funding needs but the proposed budget addresses the priorities of Council. Ms. Newbille stated that Council is committed to providing a quality education to students.

President Chris Hilbert extended thanks to Council staff and others within the city that helped to finalize the proposed budget.

There being no further comments or discussions, all **budget related papers were unanimously adopted.**
