Call to Order

Chair Reva Trammell called the meeting to order at 5:08 p.m.

Chamber Emergency Evacuation Plan and Citizen Speaker Guidelines

City Clerk Candice Reid provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Member Andreas Addison arrived and was seated.

Public Comment Period

There were no public comments.

Approval of Minutes

Member Addison moved to approve the March 27, 2018, Public Safety Standing Committee meeting minutes.

The motion was seconded and unanimously approved.

Presentations

Pulsepoint

Richmond Department of Fire and Emergency Services Staff Battalion Chief Tracy Thomas presented information regarding Pulsepoint software technology and reported that the department was able to secure an endowment from the 100 Club to purchase the software. Ms. Thomas stated that the Pulsepoint software is integrated into the city's 911 dispatch, so should a citizen call 911 to report someone in cardiac arrest, other citizens in the immediate vicinity are alerted that CPR is needed and notifies them of the nearest AED. Battalion Chief Thomas indicated that there are two mobile device applications (apps): Pulsepoint Responder and Pulsepoint AED. Ms. Thomas displayed videos demonstrating how the apps work and answered questions from the committee.

Vice Chair Kristen Larson requested information regarding the technology to include in the 4th District newsletter and expressed interest in facilitating a Pulsepoint partnership between the fire department and the Richmond Ambulance Authority.

Chair Trammell requested that Ms. Thomas present Pulsepoint at a future 8th District meeting.

Richmond Fire and Emergency Services Department

Richmond Fire and Emergency Services Chief Melvin Carter reviewed the department's organizational chart and personnel strength stating that there are four divisions: administration, operations, support services and emergency management. Mr. Carter informed the committee that the department's workforce is authorized at 434 personnel, and there are currently 269 firefighters, 16 recruits in the fire academy, 31 sworn vacancies and three non-sworn vacancies. He also informed that the department is recruiting 12 pre-certified firefighters to reduce its overtime budget. Chief Carter responded to questions and comments from Chair Trammell regarding vacancy impact on city fire stations and raising awareness of rising cancer diagnoses among firefighters.

Richmond Police Department's (RPD) Anti-Prostitution Efforts

RPD Second Precinct Lieutenant David Naoroz addressed the committee stating there are now additional walking officers patrolling the Jefferson Davis Highway area for criminal activity including prostitution. Lieutenant Naoroz informed the committee that the department has created focus mission teams of six to eight officers, and three arrests for prostitution were made at the end of January during a team mission. Lieutenant Naoroz answered questions from committee members regarding rehab resources

for offenders and how prostitution is targeted. Deputy Police Chief Steve Drew was also present to respond to questions.
