**PURPOSE:** To authorize the Chief Administrative Officer (CAO) to accept funds in the amount of \$279,978 from the Greater Richmond Transit Company and to appropriate the amount of \$279,978 to the FY2018 Special Fund Budget by increasing the estimated revenues and the amount appropriated to a new special fund of Economic & Community Development called the Pulse BRT Business Support Fund.

**REASON:** To accept \$279,978 from the Greater Richmond Transit Company to assist businesses with parking and beautification within areas that were directly impacted by the prolonged construction of the Pulse BRT.

**BACKGROUND:**

The 7.6 mile Pulse Bus Rapid Transit (BRT) construction project began in fall of 2016 between Willow Lawn and Rocketts Landing. The median lanes on Broad Street have been permanently closed between Thompson Street and Adams Street to accommodate the dedicated Pulse BRT travel lanes and median stations. The curb lane will be permanently closed to traffic on Broad Street from Foushee to 14<sup>th</sup> Street to accommodate the dedicated Pulse BRT travel lanes and curb stations. Curb stations are also constructed on Main Street from 14<sup>th</sup> Street to Rocketts Landing.

In order to construct the Pulse BRT safely, Maintenance of Traffic (MOT) measures were established to accommodate the construction activity and equipment. The MOT in many areas adjacent to the median and curb running stations include removal of on-street parking and temporary closure of sidewalks. While access to businesses have been maintained at all times throughout construction, business owners have reported difficulties due to the construction activity and parking impacts.

In FY2018, City Council appropriated \$719,944 to GRTC for nine months of operations of the Pulse Bus Rapid Transit that was expected to launch in October, 2017. However, the project did not achieve incentivized project milestones that would allow for early construction completion and launch of the Pulse BRT. GRTC has stated a cost savings of \$279,978 due to the delayed opening of the Pulse. As such, the funds associated with the cost savings will be returned to the City of Richmond and deposited into the Pulse BRT Business Fund to be used for parking related programs and beautification. Beautification may include sidewalk power washing, installation of planters and/or hanging baskets.
