- 5. Small minority business development organization
- 6. Technical educational institution
- 7. Higher educational institution
- Law enforcement 8.
- State or local department of social services 9.
- Administrator of a community-based corrections program 10.
- Faith-based community organization 11.
- **Business community** 12.
- 13. Council member representing the district in which the Justice Center is located


