AWARDS AND PRESENTATIONS

President Chris Hilbert, on behalf of Richmond City Council, recognized Councilwoman Reva Trammell on her sixteen years of service to the citizens of the 8th Council District. Vice President Cynthia Newbille awarded Councilwoman Trammell with a lapel pin for her previous fifteen years of service.

CITIZEN COMMENT

Princess Blanding expressed her dissatisfaction with the decision of the Commonwealth's Attorney regarding the shooting death of her brother, Marcus-David Peters, by a city police officer.

Sam LaGrone expressed his concerns with electric scooters in the city, especially when the scooters are ridden on the sidewalks in addition to the normal pedestrian traffic.

Councilor Kim Gray commented that all Council members should investigate the use and safety of motorized scooters within their districts.

Councilor Parker Agelasto acknowledged Ms. Blanding's comments, stating that Council does listen to citizens.

Support

Omari Al-Qadaffi spoke in support of **ORD. 2018-208** stating that the creation of an urban plaza offers an opportunity to implement many citizen recommendations and also offers economic growth.

Carol Adams spoke in support of **ORD. 2018-213** stating that the special use of 2600 Idlewood Avenue will allow for a social service delivery of resources to be used by citizens who are victims of domestic violence.

Councilor Parker Agelasto expressed his support of **ORD. 2018-213** and expressed appreciation to Ms. Adams for taking the lead in providing services to individuals a crisis. Mr. Agelasto also stated that he supports **ORD. 2018-212** and noted that he is a member of the church referenced in the proposed ordinance.

Councilor Kim Gray expressed her support of **ORD. 2018-213** and informed citizens of the work that Ms. Adams has completed to assist others within the community. Ms. Gray also explained that, if adopted, **RES. 2018-R072** will prohibit former city employees from providing assistance to another entity for personal gain for one year after employment ends.

Vice President Cynthia Newbille expressed her appreciation to Ms. Adams for the work that she has done within the community to address domestic violence.

There were no further comments or discussions and **the Consent Agenda was unanimously adopted.**

Councilor Kim Gray stated that the proposed resolution would not allow individual Council members to spend \$5,000 but should their collective payments to a vendor exceed \$5,000, a resolution would be generated to pay the additional amount.

Councilor Kristen Larson stated that the adoption of **RES. 2018-R066** will offset the amount of valuable time needed by staff to generate a resolution to pay a vendor any overage above a \$1,000 threshold.

There were no further comments or discussions and **RES. 2018-R066 was unanimously adopted.**
