AWARDS AND PRESENTATIONS

Councilor Kim Gray, along with all members of Council, recognized the Richmond Triangle Players theatre troupe on the occasion of its 25th anniversary of theatre production season.

Councilor Kim Gray, along with all members of Council, recognized the Department of Parks, Recreation and Community Facilities Movies in the Park Program.

Councilwoman Reva Trammell, along with all members of Council, recognized Richmond Police Captains Greer Gould, 1st Police Precinct Commander, and Michael Snawder, 2nd Police Precinct Commander, for their work on behalf of the community.

CITIZEN COMMENT

David Harris Jr., representative of the Black Business Alliance of Virginia, addressed Council regarding a need for the city to increase minority participation in economic development projects. Mr. Harris urged city leaders to become aggressive in its practices to ensure that blackowned businesses are included in economic opportunities.

Loren Glasper, speaking on behalf of the members of the Black Business Alliance of Virginia, remarked that the Commonwealth and the city discussed improving black-owned businesses' participation in economic development projects; however, little progress has been made to achieve that goal. Ms. Glasper further remarked that the city needs to improve its efforts to decrease the gap in business opportunities for black and minority businesses.

Julian Bowers, **member of the Black Business Alliance of Virginia**, stated that, city leaders need to actively work to reduce the disparities regarding black-owned businesses' participation in economic development opportunities. Mr. Bowers explained that approximately eleven years ago, he heard similar discussions relative to the economic injustice and exclusion of black-owned business in city projects; however, there has been very little change for the African American communities.

Wanda Stallings indicated that several residents have sustained serious injuries from falls on some of the city's cracked and uneven sidewalks in the Jackson Ward neighborhood. Ms. Stallings urged the city be more aggressive in its efforts to remedy the problems.

Debbie Roberts addressed Council regarding inconveniences she, other daily riders and senior citizen riders have experienced with the Greater Richmond Transit Company's new bus routes. Ms. Roberts reported that her once fifteen-minute commute to work or home, now consists of several transfers, longer travel time and further walking distances to the bus stops. She stated that the design of the new network system does not correlate with the needs of the riders and urged Council to refine the new system.

Opposition

Arthur Burton spoke in opposition to **RES. 2018-R069** and remarked that Council has not addressed the plea of residents in the city's public housing communities regarding new leadership, ideas and policies for the Richmond Redevelopment and Housing Authority. Mr. Burton urged Council to revise current economic development practices in order to increase opportunities for black-owned businesses.

Support

Omari Al-Qadaffi spoke in support of **ORD. 2018-172** and **ORD. 2018-173** stating that economic development projects could be a platform for the city to begin addressing economic inequality in the city's African American communities, and that he would like to see more economic opportunities for the city's black-owned businesses.

Councilor Kristen Larson expressed her support of ORD. 2018-182 and ORD. 2018-188.

There were no further comments or discussions and **the Consent Agenda was unanimously adopted.**

Councilor Andreas Addison moved to correct a previously approved agenda amendment for the following:

RES. 2018-R045

To request that the Chief Administrative Officer annually cause to be conducted a review of dedicated funding strategies for Richmond Public Schools and provide the Council, the Mayor, and the School Board of the City of Richmond with recommendations concerning (i) the total budget appropriation for Richmond Public Schools for each ensuing fiscal year, (ii) funding sources for Richmond Public Schools, and (iii) any proposed changes to state legislation necessary to increase state funding to Richmond Public Schools.

To be amended and considered

The motion was seconded and unanimously approved.

Councilor Michael Jones remarked that a large percentage of the city's B-3 General Business District, which permits night clubs and other entertainment industries, is located in the 8th and 9th Council Districts and that he would like to explore alternative zoning classifications to minimize a concentration of these establishments in the city's Southside.

Councilor Parker Agelasto stated that he was willing to work with Councilor Jones and Councilwoman Reva Trammell on possible zoning alternatives for the B-3 General Business Districts.

REGULAR AGENDA

The following ordinance was considered:

ORD. 2018-158

To conditionally rezone a portion of the property known as 5800 Patterson Avenue and the properties known as 5800, 5802, 5804, 5806, 5808, 5810, and 5812 Park Avenue; and 5801, 5803, and 5805 Pratt Street from the R-4 Single-Family Residential District to the B-7C Mixed-Use Business District (Conditional).

Matthew Ebinger, principal planner and secretary to the City Planning Commission – Planning and Development Review, explained that the City Planning Commission voted to approve the request; however, city staff was concerned that provisions to preserve the historic portions of the Westhampton School were not considered.

Opposition

Deborah Lacy expressed concern that the lease agreement does not require the developer to preserve the Westhampton School, which she says is an anchor for the neighborhood.

Stuart Stringfellow Carter, president of the Westview Civic Association, expressed concern about the impact the proposed project will have on the area's traffic and parking. Ms. Carter also expressed concern that approval of the request could set a precedent for similar developments in other residential areas.

Cyane Crump, executive director of Historic Richmond, stated that Historic Richmond opposed the proposed request and that the applicant failed to address the concerns of the residents. Ms. Crump urged Council not to approve the rezoning request without a commitment from the applicant to preserve the school buildings and request that the applicant not apply for a demolition permit until the plan of development was finalized.

Greg Lucyk asked Council to continue the proposed request to allow residents within 150 feet of the proposed development to formally submit its protest to the project. Mr. Lucyk stated that the proposed development was not compatible with the residential character of the neighborhood and was not supported by city staff.

Betsy Gardner stated that the historical school was an important part of the city's history and should be preserved. Ms. Gardner remarked that approval of the proposed request would contradict development standards outlined in the city's Master Plan. Ms. Gardner urged Council to reject the rezoning request and to require the applicant to seek approval through the special use permit process so residents could be involved with each phase of the development.

Nadia Katallski, **representative of the Westhampton Neighborhood Association**, remarked that residents were concerned about the impact the proposed project will have on the neighborhood. She stated that Council should not approve the proposed request until the applicant submits plans to preserve the historic Westhampton School buildings. Ms. Katallski asked Council to serve as a mediator on the project so that citizens can be informed of all phases of the project.

Barbara Ebert expressed concern that the Westhampton School building will not be preserved and stated that the proposed project will reduce the property values in the neighborhood, negatively impact traffic and parking and did not comply with the city's Affordable Housing Strategy.

Marty York commented that the economic development deal provided minimal financial benefits for Richmond Public Schools and that Council should not support the proposed request because plans to preserve the historic school were not included in the project's scope.

Support

Jim Theobald, representative for the applicant, stated that the applicant has met the obligations of the performance agreement which consist of three separate components. Mr. Theobald reported that the applicant has agreed to pay for the cost for a traffic study, worked with city staff and Council to limit uses of the properties, agreed to hold future public meetings to discuss the design elements and to make traffic and streetscape improvements. He stated that the proposed request represents the best platform to preserve, at a minimum, the 1917 building. He further stated that the proposed project meets or exceeds the economic development threshold established by the city and will expand on the healthcare needs of the city while maintaining Bon Secours' faith-based values.

Nancy Thomas, president of the Retail Merchants Association, remarked that the proposed request will create jobs and generate tax revenue for the city. Ms. Thomas stated that Bon Secours has remained consistent in its commitments to invest in the city. She commented that the proposed development was a much needed economic development project that will enhance the health and wealth of communities within the city.

Tonda Arthur, vice-president of the Westhampton Merchants Association, reported that the Westhampton Merchants Association supported the rezoning request and that redeveloping the properties will help local businesses within the area, enhance the neighborhood and increase revenue for the city.

Travis Bowers, president of Bowers Corporation, stated that Bon Secours supports the community and has demonstrated its commitment to the city.

Councilor Andreas Addison expressed support for the proposed request stating that Bon Secours held numerous meetings with area residents and city staff to discuss the project, had committed to exceed requirements to improve the traffic flow around the development, and to make every effort to preserve the Westhampton School. Councilor Addison reported that, in addition, Bon Secours has committed to meet with the area's residents to discuss design elements and to apply for the demolition permit after the plan of development was finalized. He further stated that the development would create jobs, increase medical services and generate tax revenue for the city.

Councilor Kim Gray stated that she held concerns about the preservation of the Westhampton School buildings, but a verbal commitment from a Bon Secours' representative dispelled those concerns. Councilor Gray also stated that she would be supporting the proposed request and agreed to closely monitor the project and to update residents on each phase of the project.

Councilwoman Reva Trammell expressed concern that information regarding the proposed development was not provided to all members of Council and moved to continue ORD. 2018-158 to the Monday, September 10, 2018, Council meeting to allow all Councilmembers the opportunity to review such information.

The motion failed for lack of a second.

Councilor Parker Agelasto expressed concerns relative to the B-7C Mixed-Use Business District, preservation of the Westhampton School, numerous extensions of the performance agreement's deadline and the loss of revenue for Richmond Public Schools. Councilor Agelasto stated that he would not support the proposed legislation; however, he would support a continuation of the proposed legislation to further evaluate whether or not the special use permit process would be more appropriate.

Councilor Kristen Larson stated that the traffic congestion in parts of the 1st District could not be resolved by a single development and that she felt confident with the commitments made by Bon Secours. Councilor Larson stressed that Council needs to thoroughly review all future economic development agreements to ensure that the city and the citizens benefit from such agreements.

Councilor Michael Jones stated that he was not comfortable approving the rezoning request because it limits City Council's consideration of certain aspects of the project. Councilor Jones asked Council to consider continuing ORD. 2018-158, to allow time for other options to be considered.

Vice President Cynthia Newbille expressed support of the proposed legislation citing commitments by Bon Secours to invest in the city's East End, to preserve at least the 1917 portion of the school buildings, to not begin demolition until after the review of the plan of development, and to provide funding for a traffic study.

Councilor Ellen Robertson asked Mr. Theobald whether or not the applicant was willing to submit the conditions of zoning submitted to the City Planning Commission to City Council as a part of the rezoning request.

Mr. Theobald stated that Bon Secours' Board of Directors agreed to submit the verbal commitments to City Council, and he clarified that the applicant agreed to make every effort to preserve at least the 1917 portion of the Westhampton School building. Mr. Theobald also agreed to provide Council with a copy of an approval letter from Bon Secours' Board of Directors for the construction of the medical office building in the city's East End.

President Chris Hilbert stated that he regretted his vote to support the Washington Redskins Training Center agreement, and he was not willing to support the proposed request because Bon Secours failed to execute the terms of the original agreement to build a nursing school. President Hilbert urged Council to reject ORD. 2018-158.

Councilor Michael Jones moved that ORD. 2018-158 be continued to the Monday, September 24, 2018, Council meeting, which was seconded.

The motion failed: Ayes 4, Jones, Agelasto, Trammell, Hilbert. Noes 5, Robertson, Larson, Gray, Addison, Newbille.

Councilor Agelasto noted that, he will not support future economic development projects unless there are assurances that they have proper oversight and there is recourse if deadlines are not met.

Councilor Agelasto and Councilwoman Trammell reported that they do not support ORD. 2018-158.

There were no further comments or discussions and **ORD. 2018-158 was adopted:** Ayes 5, Robertson, Larson, Gray, Addison, Newbille. Noes 4, Jones, Agelasto, Trammell, Hilbert.
