

RE: To authorize the Greater Richmond Transit Corporation (GRTC), in partnership with the City of Richmond, to provide all GRTC patrons with free bus rides on Election Day, November 6, 2018.

PURPOSE: To authorize GRTC to provide free bus rides on Election Day, November 6, 2018 for all patrons utilizing the bus system to increase civic participation.

REASON: To provide GRTC customers with one day of free rides on November 6, 2018.

RECOMMENDATION: Approval is recommended by the City Administration.

BACKGROUND: The City of Richmond is committed to providing all citizens with the best possible transportation to allow them faster service and connectivity. As a result, the City Administration, in partnership with GRTC, is recommending that all GRTC patrons be provided with free transportation on GRTC buses on Election Day, November 6, 2018. This is an effort to not only assist residents in traveling throughout the GRTC network, but to also increase electoral and civic participation for all by removing transportation as an obstacle. GRTC's new bus routes allow for easier access to riders who wish to vote at precincts across the City as the majority of the bus stops are a few blocks from a voting precinct. This partnership with GRTC, City Administration, and the community will help ensure that all GRTC patrons, particularly city residents,

have less transportation limitations to access their respective polling facilities on this particular day.

FISCAL IMPACT / COST: The administration intends to utilize any available general fund surplus from FY18 toward the estimated cost. GRTC has estimated the cost to be \$24, 310. It is the Administration's intent, if available, to earmark funds as a part of the FY2018 Assigned Fund Balance (separate from the Unassigned fund balance) for GRTC, specifically for the purpose outlined within this O&R request. A second O&R request, later in the fall, will be needed to amend the FY2019 general fund budget by appropriating \$24,310 from the Assigned Fund Balance, to the GRTC line item within Non-Departmental.

FISCAL IMPLICATIONS: City Administration intends to assign \$24,310 from any available general fund surplus at the close of FY18. It is expected that GRTC will submit an invoice for payment following November 6, 2018, at which time, pending City Council approval, the final amount will be transferred from the Assigned Fund Balance to the GRTC line in the Non-Departmental budget.
