PURPOSE: To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute an agreement between the City of Richmond and E.LocalLink, Inc., consisting of a document captioned as "The Community Video Program" together with a document entitled "Addendum to Contractor's Standard Form," for the purpose of enabling the City to participate in a Community Video Program.

REASON: The agreement obligates the City to maintain on the City's www.richmondgov.com homepage a link to non-government webpage for a period of three years.

RECOMMENDATION: The City Administration recommends adoption of this ordinance.

BACKGROUND: The City has the opportunity to participate in a Community Video Program, endorsed by the National League of Cities, the United States Conference of Mayors, and the National Association of Counties. The program, provided by E.LocalLink, Inc., involves a link on the local government's homepage. The link leads to a non-government website where videos marketing various aspects of the locality are published. The local government does not pay for the videos; E.LocalLink, Inc. instead sells sponsorships and video services to local businesses, displayed surrounding the local government's videos.

The videos marketing the City coupled with the videos and sponsorships marketing local businesses allow greater visibility for both the City itself and the sponsoring local businesses, which promotes economic activity and tourism in the City. The Addendum to Contractor's Form pro-

vides the City with greater control over the content and substance of the video program than the E.LocalLink, Inc. contract form.

ADDENDUM TO CONTRACTOR'S STANDARD FORM

The City of Richmond, Virginia (the "City"), a municipal corporation and political subdivision of the Commonwealth of Virginia, and E.LocalLink, Inc. ("E.LocalLink"), a New York corporation, are this day entering into a contract. For their mutual convenience, the City and E LocalLink are using the one-page standard form agreement captioned as "Community Video Program" provided by E.LocalLink (the "Contractor's Form"). This Addendum, duly executed by both the City and E.LocalLink, is attached to and hereby made a part of the Contractor's Form. Together, this Addendum and the Contractor's Form constitute the "Contract" between the City and E.LocalLink. The Contract is effective as of the date on which the City's Chief Administrative Officer signs this Addendum.

- A. E.LocalLink represents and warrants that it is a legal entity authorized to do in Virginia the business provided for in the Contract. In its performance under the Contract, E.LocalLink acts and will act as an independent contractor and not as an agent or employee of the City.
- B. The Contract has been reviewed by staff of the City. Its substantive terms are appropriate to the needs of the City, and sufficient funds have been allocated for its performance by the City. The Contract is subject to appropriations by the City Council of the City. Notwithstanding anything in the Contractor's Form, neither the City nor its officers, employees, or agents shall have any financial liability in connection with the Contract or in connection with any goods, services, actions, or omissions relating to the Contract.
- C. In consideration of the convenience of using the Contractor's Form, the City and E.LocalLink agree to the following exceptions or modifications to the Contractor's Form:
 - 1. E.LocalLink shall not make available any video accessible, directly or indirectly, from or through the "Community Video Program" link on the City's homepage unless and until the City has approved in writing the content of the video.
 - 2. E.LocalLink shall not knowingly make available any video accessible, directly or indirectly, from or through the "Community Video Program" link on the City's homepage that infringes on any third party's copyright, trademark, or other intellectual property, privacy, or publicity right. For the avoidance of doubt, this provision applies to videos produced both for the City and for business sponsors in connection with the Community Video Program provided for the City.
 - 3. E.LocalLink represents that, as of the date on which the City executes this Agreement, E.LocalLink has furnished the City with a list of all business sponsors with whom E.LocalLink has entered into a contractual arrangement providing for the business sponsor to be featured around the perimeter of video panels in connection with the Community Video Program provided for the City.
 - 4. E.LocalLink shall obtain the City's prior written approval before E.LocalLink enters into a contractual arrangement with any business sponsor not on the list referred to in item 3 above providing for the business sponsor to be featured around the perimeter of video panels in connection with the Community Video Program provided for the City.
- D. This Addendum and the Contractor's Form constitute the entire agreement between the City and E.LocalLink and may not be waived or modified except by written agreement between the City and E.LocalLink.

In WITNESS WHEREOF, the City and E.LocalLink have caused the Contract to be duly executed, intending thereby to be legally bound, as of the date on which this Addendum is signed by the City's Chief Administrative Officer.

("ELL") and the City of Richmond (the "City") and shall remain in affect from the date it is signed by both parties until the third anniversary of the date that the completed and approved Community Video Program is made available for viewer access on different devices via a link on the www.richmondgov.com homepage, including any afternate versions of that homepage.

Ouring the term of this Agreement, ELL shall;

- Produce 5 video chapters with subject matter that includes, but is not limited to: Welcome, Education, Healthy Living, Homes / Real Estate, and two (2) additional videos of City's choice
- Provide one Community Organizations chapter to promote charities, nonprofits and community development organizations
- Provide script writing and video content consultation
- Send a videographer to City locations to shoot footage for the videos
- Reserve the right to use still images and photos for video production
- Provide all aspects of video production and editing, from raw footage to final video including professional volceovers and background music
- Provide a final draft of Community Video Program content subject to City's approval, with up to 3 sets of revisions allowed. Any ELL request
- From the first track of the fir
- Feature business sponsors around the perimeter of video panels
- Be solely responsible for sponsorship fulfillment including all related aspects of marketing, production, printing, and distribution
- Facilitate viewer access of the Community Video Program from City website, including any alternate versions of City's homepage, for different devices, by providing HTML source code for a graphic link to be prominently displayed on the www.richmond.gov.com website

homepage as follows: "Coming Soon" graphic link designed to coordinate with existing website color theme to be provided within 10 business days of execution of this agreement. "Community Video Program" graphic link to be provided to replace the "Coming Soon" link upon completion and approval of videos

- Grant to City a ficense to use ELL's Line of Code to link to and/or stream the videos
- Own copyrights of the master Community Video Program
- Assume all costs for the Community Video Program
- Afford businesses the opportunity to purchase various digital media products and services from ELL and its affiliates

Program add-ons will include:

ELL will include multiple segments of serial footage

During the term of this Agreement, the City shall:

- Provide a letter of introduction for the program on City's lotterhead Assist with the content and script for the Community Video Program
- Grant ELL the right to use City's name in connection with the preparation, production, and marketing of the Program
- Display the "Coming Soon" graphic link prominently on the www.richmondgov.com homepage within 10 business days of receipt of HTML source code
- Display the "Community Video Program" link prominently on its www.richmondgov.com homepage, including any atternate varsions of that home page, for viewer access on different devices for the entire term of this agreement
- Ensure that this agreement remains valid and in force until the agreed upon expiration date, regardless of change in administration
- Grant full and exclusive streaming video rights for ELL and its subsidienes, effiliales, successors and assigns to stream all video content produced by ELL for the Community Video Program
- Agree that the city will not knowingly submit any photograph, video, or other content that infringes on any third party's copyright, trademark or other intellectual property, privacy or publicity right for use in any video or other display comprising this program.

This Agreement constitutes the entire agreement of the parties and supersedes any and all prior communications, understandings and agreements, whether oral or written. No modification or claimed waiver of any provision shall be valid except by written amendment signed by the parties herein. City warrants that it is a tax exampt entity. The undersigned have read and understand the above information and have full authority to sign this agreement.
